**RESOLUTION DECLARING CERTAIN PERSONAL PROPERTY

WHEREAS, the City Administrator of the City of Washington and the Chief of Police have advised the City Council that said personal property is no longer necessary or useful to the City of Washington in its operations or in the performance of its programs and services; and

WHEREAS, the City Administrator has caused to be prepared a list of said personal property, which list has been forwarded to the Mayor and City Council for review and disposition and is attached hereto, marked “Exhibit 1.”

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS, as follows:

That the personal property identified on Exhibit 1, hereto attached and by reference expressly made a part hereof, used by the City of Washington be, and the same hereby are, declared to be surplus property as same is no longer necessary or useful to the City of Washington in its operations or in the performance of its programs and services.
