Mayor Manier read a letter from Mayor Robert Eschbach, City of Ottawa, that introduces a proclamation to the City of Washington in recognition of our assistant through IPWAMAN following their EF3 tornado that impacted the Ottawa area on February 28, 2017. Public Works Director Andrews shared that IPWMAN is the Illinois Public Works Mutual Aid Network that we have been a member of since just prior to our tornado in 2013. He shared that he attended their annual conference in Bloomington and had brought back information about a month prior to the 2013 tornado and had received insurance coverage clearances on Friday before the tornado hit on Sunday. He shared we have been a member since that time and were able to also offer two days of assistance to the City of Quincy about a year ago. Mayor Manier shared that it is great to have the capabilities of doing this for others and shared his appreciation to Jim and Ed for their efforts in coordinating this for the City of Ottawa. Mayor Manier shared that we have been recently made aware of the possible sale of Sundale Utilities, Inc., which currently provides water and sewer services to approximately 400 city residents and businesses in the Washington Estates area to Illinois American Water Company. He shared that they are currently seeking approval from the Illinois Commerce Commission (ICC) and the City is investigating the ramifications of its possible sale in order to determine the impact it may have on some of our residents. He shared we have requested more information from them and may be taking a position in May and will be forwarding any new information to Council as it comes in. He shared that we want to protect our residents as much as we can in this process.	
Mayor Manier shared that he attended the ribbon cutting for the new laser tag addition at Plaza Lanes and it will be a great addition to our community.	
City Administrator Culotta requested Council approval of the FY17-18 Non-Union Pay Plan. He shared that the pay plan includes a 3% general wage increase. Adoption of this resolution would appropriate \$1,840 to fulfill the City’s financial obligation to the Illinois Department of Transportation regarding traffic signal upgrades. Alderman Dingledine moved and Alderman Brownfield seconded to adopt the resolution as read. Alderman Dingledine asked what the upgrades consisted of and Public Works Director Andrews shared that it will be modifying the controller cabinet, installing new signal heads, backplates, and a battery backup system at the U.S. Route 24 and N. Adoption of this ordinance would approve the City of Washington’s budget for the Fiscal Year beginning May 1, 2017 and ending on April 30, 2018 in the amount of \$27,074,437. As required by state statute, a public hearing on the City’s FY17-18 Tentative Annual Budget was held at 6:30 p.m. on Monday, April 10, 2017. Alderman J. Adoption of this ordinance would approve a TIF redevelopment agreement with S&S Properties, LLC, for the redevelopment of 116-126 Peoria Street. Adoption of this ordinance would authorize an agreement with the Illinois Department of Transportation regarding upgrades to intersection traffic signals at U.S. Route 24 and N. Cummings Lane, which include modifying the controller cabinet, new signal heads, backplates, and a battery backup system. It also obligates the City to pay its cost share amount of \$1,840.
