Re: ATV Purchase

Background

The Washington Police Department recently sought bids for the purchase of an ATV for use in policing various outdoor community events. Those types of events include, but are not limited to, fairs, festivals, sporting events, and organized runs. The unit is also intended for use in patrolling recreation trails, rough terrain uses and any other venue that does not lend itself to automobile traffic.

Summary

The ATV finds its practicality in allowing officers to more effectively police venues that would otherwise be unwieldy for regular patrol vehicles or venues so densely populated with people that vehicle use is unsafe. The ATV allows for the transport of medical supplies and other equipment that an officer on foot patrol simply cannot manage in these policing endeavors. Finally the ATV allows for positive community interaction, through the ability to transport residents or visitors as a courtesy outreach.

Two area dealers carried the Polaris Ranger ATV that we were seeking to purchase. These dealers were German Bliss Equipment in East Peoria and Cupis Motor Mall in North Pekin. Other models were considered and priced but were either significantly higher in price or the quality was not substantial enough to meet the ten year service life that we are expecting out of this unit.

German Bliss bid a 2016 Polaris Ranger, Model 570 Crew Cab for the amount of **\$13,600.**

Cupi's Motor Mall bid a 2017 Polaris Ranger, Model 570 Crew Cab for the amount of **\$12,776.**

Requested Action

The purchase of the ATV has been provided for in the 17/18 fiscal budget. It has been taken in front of the Committee of the Whole for approval. I am requesting Council approve the bid of Cupi's Motor Mall for the amount of **\$12,776**.
