SUBJECT: STP#2, Phase 2A Geotechnical Services

with Whitney & Associates

DATE: June 9, 2017

At the February 1, 2016 Council Meeting the City committed to award River City Construction, LLC in an amount of \$3,562,500 for the Phase 2A expansion of Sewer Treatment Plant #2 (STP#2). The formal contract itself was executed with IEPA approval on May 31st 2016, with work onsite beginning in June.

The contract provided for portions of the materials testing to be borne by the Contractor and geotechnical testing to be borne by the Owner. This is under Section 02222 – Excavation, Fill, Backfill and Grading, Article 3.13 of the project specifications.

3.13 COMPACTION TESTING

A. Compaction tests shall be done by the Project Soils Engineer. Location and frequency of the tests shall be as recommended by the Project Soils Engineer and paid for by OWNER.

END OF SECTION

Whitney & Associates has provided this testing, as well as the other materials testing borne by the Contractor throughout the project. Final geotechnical testing costs have accrued to an amount of \$12,688, with the periodic monthly costs attached.

As such it is my recommendation that the City Council approve making payment to Whitney & Associates as provided for in the division of contract testing in an amount not to exceed **\$12,688**.

This matter has been placed on the agenda for the City Council meeting of Monday, June 12th, 2017, for review and consideration.
