Executive Summary

Elected Official participation in IMRF must be approved by resolution of the City Council every two years. City Clerk Pat Brown qualifies for participation in such that she works more than the 1,000 hours/year threshold.

Background

In 2009, a Resolution was approved to allow Elected Officials working more than 1,000 hours per year to participate in IMRF. This specifically related to City Clerk Pat Brown. IMRF is now requiring a recertification of participation every two years.
