

## RESOLUTION \_\_\_\_\_

Synopsis: The following resolution would allow an Intergovernmental transfer of a Vermeer Brush Chipper, a Sullaire Air Compressor and a Kohler 50kw generator from the City of Washington to the Washington Township Road District for an amount of \$1.00.

### **RESOLUTION AUTHORIZING AN INTERGOVERNMENTAL TRANSFER OF EQUIPMENT FROM THE CITY OF WASHINGTON, ILLINOIS, TAZEWELL COUNTY TO THE WASHINGTON TOWNSHIP ROAD DISTRICT, WASHINGTON ILLINOIS, TAZEWELL COUNTY**

**WHEREAS**, the Intergovernmental Cooperation Act, as enacted by the State of Illinois, Section 3.01 (5 ILCS 220/3) provides as follows: “Any power or powers, privileges or authority exercised or which may be exercised by a public agency of this State may be exercised and enjoyed jointly with any other public agency of this State”; and;

**WHEREAS**, the City of Washington and Washington Township Road district agree that it is beneficial to transfer a Vermeer Brush Chipper, a Sullair Air Compressor, and a Kohler 50kw Generator, property which has been determined obsolete by the City of Washington, to Washington Township Road District for the consideration of one dollar (\$1); and;

**WHEREAS**, the air compressor and the generator have been deemed non-functional pieces of equipment by the City of Washington, and;

**WHEREAS**, the Washington Township Road District believes that they can restore the equipment for their use, and;

**WHEREAS**, it is in the mutual interest of both the City of Washington and the Washington Township Road District to have periodic access to a chipper;

**WHEREAS**, the City of Washington understands the Washington Township Road District’s need for a Vermeer Brush Chipper, a Sullair Air Compressor, and a Kohler 50kw Generator and agrees to transfer this equipment in “as is” condition.

Washington Township Road District agrees to maintain and provide reasonable use of the chipper to the City of Washington upon request of one week’s notice for up to two weeks of operation per year for a period of five years from the date of this agreement.

**NOW, THEREFORE, BE IT RESOLVED** that the City of Washington, Illinois does hereby declare the transfer of this equipment currently housed at its Public Works garages and authorizes the Director of Public Works to execute any documents which may be necessary in order to effectuate the purpose of said Intergovernmental transfer.
