EXECUTIVE SUMMARY:

On August 17th, a re-bid of the above-mentioned project was held. The current budget provides for these two upgrades at \$220k for the Brine Tanks and \$160k for the Chlorine separation.

It is recommended that the award for this be made to River City Construction in a not to exceed amount of \$450,000.

BACKGROUND NARRATIVE:

This project was originally bid on June 28, 2017 with the apparent low bidder, Laverdiere Construction withdrawing their bid of \$389,900 for not including their piping subcontract for an amended amount of \$461,900. At that time, the second low bid was Peoria Metro Construction at \$595,900, well above the available budget. The City's attorney found that we could not accept an amended bid and portions of the project revised to help reduce staging and excavation costs.

Replacement of the existing brine tank (vintage 1959) and the addition of a second brine tank is needed to support the softening of the drinking water at WTP#1. These are cast-in-place concrete tanks of an approximate size of 10'x20'x10'. The need for two tanks is required under the Ten State Standards and IEPA. Additionally, WTP#1 has a combined chemical room, while previously permitted by the IEPA in the early 1980's current regulations are such that chlorine and fluorosilicic acid (fluoride) must be separated for worker safety. The City is under a directive by the IEPA to make these upgrades.

The results of the bid are detailed in the attachments and summarized below.
