STP#2 Sewer - Lining vs Spot Repair

The 18" western interceptor sewer coming into STP#2 has developed a sink hole and was TV'd (to the extent possible while under flow) by Staff to review problems with the line. Two spot repair locations in the first 305' were identified for repair. Quotes for spot repairs were obtained from Hoerr and GA Rich, see below and attachments:

GA Rich

Spot Line @\$6800 per

\$13,600

Hoerr

Spot Line @\$4,150 per

\$8,300

Line Run @ \$65/LF

\$19,825

Note: GA Rich cannot do full line runs.

It is staff's recommendation to fully line the sewer for 305'

Project: CIPP Sewer Lining for the City of Washington

### Hoerr Construction, Inc. to Provide

- Option 1: Sectional Point Repair CIPP of 18" Interceptor
  - o Cleaning & televising of pipe to the extent of allowing placement of point repairs
  - o 18" x 50" fiberglass/epoxy CIPP liner
  - Two locations, 221' and 249' from upstream manhole, to cover separated and infiltrating pipe joints
- Option 2 & 3: Manhole to manhole CIPP of 18" Interceptor
  - Televising of pipe prior to lining, as a separate operation
  - o Cleaning and televising of pipe immediately prior to liner installation
  - Cured in Place Pipe (CIPP) for 18" clay sanitary sewer
    - Option 2: 305' in segment with developing sinkhole
    - Option 3: 965' to line from corner to plant
  - All necessary equipment and labor for liner inversion, cure & lateral reinstatements
  - Bypass pumping
- Post-lining televising with DVD video report
- Quote based of off information provided in meetings with City employees and partial video provided.
  Changes in actual conditions found during preparatory work could result in price adjustments.

#### City of Washington to Provide

- · Water for pipe cleaning operations via hydrant fill
- Dump site for debris removed from pipe during cleaning (should be minimal)
- · Access to pipe being lined to include, but not limited to, access to all manholes
- Notices to anyone in the cleaning and lining area that might be affected
- Any necessary bonds, permits, fees, association dues, special insurance coverage, surface restoration, erosion control, deflection testing, air testing, or staking
