

SUBJECT: Sanitary Sewer Treatment Plant (STP) #2

Liquid Sludge Tank Repairs

## **EXECUTIVE SUMMARY:**

Sewer Treatment Plant (STP) #2 uses an Aquastore storage tank to storage liquid sludge while drying and/or pressing operations process it into a desiccated material for disposal.



This tank was recently drawn down and cleaned to allow for inspection of the tank and periodic replacement of sacrificial anodes to maintain cathodic protection. The inspection was again performed by Cady Inc. of Tampico, IL (the regional OEM Aquastore rep) with requested emphasis on the review of the glass lining by staff. They identified and submitted pricing for correction of the following items:

- Repair of ice damage to the interior sidewall sheets by cleaning and applying sealant.
- Replacement of one zinc anode
- Repair of the exterior top platform (ladder) connections with bearing plates to alleviate concentrated loading contributing to sheeting

Cady Inc proposed this effort at \$9,532 with scheduled availability in mid-November. By follow up communications on 9-20-17, they indicated they would be able to discount remobilization if they could undertake repairs next week.

As such, it is recommended to contract with Cady Inc. for a not to exceed amount of \$8,691 (\$9,532, less remobilization discount of \$841) for repairs to the sludge storage tank.
