SUBJECT: Municipal Compliance Report

Attached is the Municipal Compliance Report per House Bill 5088 (Public Act 95-950) that is required to be provided to the City Council prior to the levying of taxes.

The past year showed positive earnings as indicated by the 7.56% investment yield; however, the five-year smoothed rate is 4.19% and that is the rate that must be used in determining the tax levy requirement. Because this rate of 4.19% is less than the assumption of 6.75%, the tax levy requirement has increased to \$550,691.

The tax levy requirement may be partially satisfied by Personal Property Replacement Tax which is projected to total \$15,000 (estimated to be down 20% from the prior year total of \$19,300). Accordingly, the **resulting** tax levy would be \$535,700, a \$35,700 or 7.14% increase over the prior year.
