Mayor and Aldermen,

Last Fiscal year, the Department purchased four hand-held radar units to replace obsolete units. The obsolete units have been stored. MSgt Stevens contacted four used radar dealers to obtain quotes for sale of the obsolete radars. Only one vendor responded. That vendor, PB Electronics, offered to purchase the HTCR-1KD Genesis handheld directional radars for \$125 each.

Our request is that the City Council declare the four radar units obsolete and authorize sale of the radars to PB Electronics for \$125 each.

**RESOLUTION DECLARING CERTAIN PERSONAL PROPERTY

WHEREAS, the City Administrator has caused to be prepared a list of said personal property, which list has been forwarded to the Mayor and City Council for review and disposition and is attached hereto, marked "Exhibit 1."

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WASHINGTON, TAZEWEEL COUNTY, ILLINOIS, as follows:

That the personal property identified on Exhibit 1, hereto attached and by reference expressly made a part hereof, used by the City of Washington be, and the same hereby are, declared to be surplus property as same is no longer necessary or useful to the City of Washington in its operations or in the performance of its programs and services.
