Audience Comments Washington Police Officer and Union President Ryan Grossman, expressed his appreciation and thanks on behalf of the Patrol Officer Union, to all for working through the process and coming

to an agreement that's beneficial for the City and its Officers. He thanked City Administrator Culotta for being professional, reasonable, and open through negotiations and thanked Police Chief McCoy for his work as well. He shared that it was the best labor management he's known

since becoming an officer.

He shared that Committee is recommending approval with a 2nd reading waiver request on Ordinance D. Alderman Brownfield, Public Works Committee Chairman reported three items on the agenda (Ordinances C & E, & Staff Reports E). Mayor Manier shared his appreciation to Police Officer Grossman for his comments and his Mayor's Comments

> service and thanked him for his work through the negotiating process. He congratulated Alderman Moss for all her hard work in preparing for the 10th annual Wreaths Across America ceremony that took place this past Saturday. Alderman Moss shared that it was a wonderful turnout and the ceremony went very well. She shared that this year we had a snafu with the delivery of the 805 sponsored wreaths that were to be delivered prior to the ceremony and they will not be coming until this coming Thursday. She shared that after trying to make contact on the whereabouts of the wreaths that she finally did get a response 2 days later indicating that they had had a total system failure and were basically working in the dark on getting wreaths to their destinations. She shared that once the wreaths get here on Thursday volunteers will be needed to lay the wreaths throughout the cemetery on our veterans graves. She shared that four American Heritage Girl troops sponsored 600 wreaths this year through their fundraising efforts and will be helping the lay wreaths as well. She thanked Mayor Manier, Alderman Brownfield,

and all those that participated in the ceremony this year.

He noted that the upper-end adjustment is reflective of the placement of miscellaneous sod at the back of ADA ramp upgrades. Alderman Dingledine moved and Alderman Cobb seconded to authorize the request as presented. On roll call the vote was:

Authrz emergency snow removal

Public Works Director Andrews requested Council authorization to enter into a contract for emergency snow removal assistance with Weaver Trucking & Excavating on an on-call/asneeded basis at the following quoted rates: parking lots \$750 per call; alleys \$600 per call; and hauling \$125/hour for backhoe and \$75/hour for 5YD truck. He went over the three quotations that were received noting that R.A. Cullinan submitted their hourly rates for parking lots, alleys, and hauling and Wissel Trucking submitted hauling hourly rates only. He shared that in the past recommendation has been going with the lump sum quotation on a per call basis. Alderman Brucks moved and Alderman Gee seconded to approve emergency snow removal and standby assistance. On roll call the vote was:

Aldermen's/Staff Comments Police Chief McCoy expressed his appreciation of how well the negotiating team worked together in a professional manner on the collecting bargaining process and it was evident that our Police Officers knew the City had their best interests at heart. He thanked Aldermen Brownfield and Butler and City Administrator Culotta for all their work in the process. He expressed his appreciation to Officer Taylor who headed up the Shopping with the Men in Blue program this year with over \$8,000 raised between various groups including the Officer's annual No Shave November & December, VFW, and American Legion. He shared 80 kids were able to shop with our officers which represented 30 families, our biggest group since we have been doing the program. Deputy Chief Stevens shared that there have been some recent car break ins and that only unlocked cars are being affected. He encouraged everyone to lock their car doors. Alderman Brownfield shared that the Fire Department's Santa Parade is scheduled to begin at 6:00 p.m. this Thursday and the map route is on their website.
