## CITY OF WASHINGTON, ILLINOIS CITY COUNCIL MEETING - TUESDAY, JANUARY 2, 2018 LIBRARY MEETING ROOM 380 N. WILMOR ROAD – 6:30 P.M.

Mayor Manier called the regular meeting of Tuesday, January 2, 2018 to order at 6:33 p.m. in the Library Meeting Room at Five Points Washington.

Call to Order

Present and answering roll call were Aldermen, Adams, Brownfield, Butler, Cobb, Dingledine, Gee, and Moss. Alderman Brucks was absent.

Agenda Review

Alderman Brownfield moved and Alderman Cobb seconded to approve the Consent Agenda as presented. Items included on the Consent Agenda were minutes of the December 18, 2017 regular City Council meeting; post ratification for additional aggregate, salt storage structure; payment authorization: hydra-stop insert-a-valve; authorization: Downtown Square coping wall repairs; and purchase authorization: Sewer Treatment Plant No. 2 UV bulb replacement. April Crotts addressed the Council by reading a letter pertaining to the recent citizen petition that was filed for a public question that asks for the City's election process to move from partisan elections to nonpartisan elections. She shared her concern that the item is not on the agenda for discussion this evening and that she would like to see it as an agenda item for discussion at a future meeting.

Mayor's Comments

City Administrator Culotta provided second reading of the following ordinance, by title and brief synopsis, an ordinance amending the Code of Ordinances of the City of Washington, Illinois, by amending various sections of Chapter 160 entitled "Building Code." Adoption of this ordinance would increase the temporary certificate of occupancy fee from \$1,000 to \$2,000 for new construction. Alderman Dingledine moved and Alderman Moss seconded to adopt the ordinance as read. On roll call the vote was:

City Administrator Culotta provided first reading of the following ordinances, by title and brief synopsis: an ordinance amending Chapter 72 of the Code of Ordinances of the City of Washington, Tazewell County, Illinois entitled "Parking Regulations" to restrict parking on the east side of Lincoln Street north of Jackson Street. Adoption of this ordinance would prohibit parking on the east side of Lincoln Street for 30 feet on each side of the existing north driveway of Lincoln Grade School. The purpose of the prohibition is to facilitate entry and exit of large vehicles such as school buses; and an ordinance amending the Personnel Manual of the City of Washington, Illinois to establish a policy prohibiting sexual harassment and other forms of discrimination. Adoption of this ordinance would adopt a new sexual harassment and other forms of discrimination policy which expands upon our existing policy to comply with the new IL General Assembly Public Act 100-0554. These ordinances will be listed on the next meeting agenda for action.

1<sup>st</sup> reading ords, amending Chapter 72, restrict parking on Lincoln St; and amending Personnel Manual, sexual harassment policy

Police Chief McCoy reported on the recent rash of vehicle burglaries sharing that all but one vehicle has been found. He shared that the vehicles were not broken into and that all were unlocked with the keys inside and reminded residents to lock their cars and take their keys inside. Alderman Brownfield expressed his appreciation to the Washington Fire Department and Rescue Squad for all their work in saving his Dad's life when he experienced a recent heart attack and shared that his Dad is doing well now.

Aldermen's/Staff Comments

Executive Director of Operations, Roger Traver, provided a brief report for the month of November noting 118 calls were received and for December 134 calls were received. He shared that 1,500 calls were received in 2017, which is up 10% from last year's number of 1,366.
