The annual resolution for Motor Fuel Tax Expenditures is being presented for consideration for the current calendar year of 2018.

There will be also ongoing monthly allotments received during 2018, assumed to be 9% above the monthly average of \$32,168.06 in 2017 due to the population increase in the Special Census.
