DATE: May 18, 2018

Staff is in receipt of an invoice from ESRI for the payment of the annual ArcGIS maintenance and service licenses. These include:

- ArcGIS Desktop Advanced Concurrent Use Primary Maintenance: \$3,000
- ArcGIS Desktop Basic Single Use Primary Maintenance: \$400
- ArcGIS Online Named User Level 1 Term License Includes 10 Users: \$1,183,56
- ArcGIS Online Level 2 Term License Includes 5 Users and 2,500 Service Credits: \$2,500

You will recall that staff has migrated from using ArcGIS Publisher to ArcGIS Online, as ESRI has begun phasing out AGP and moving towards the AGO platform. Please note that since we started our AGO Level 1 licenses shortly after the start of the FY 17-18, the quote for this year reflects a start date of May 7, 2018 and an end date of July 12, 2019, which would coincide with the end dates for the other three maintenance coverages. As a result, the \$100/license is prorated for the additional 60+ days to an amount of approximately \$118.36/license.

Staff seeks authorization to make payment to ESRI in a not-to-exceed amount of \$7,083.56 for the annual GIS maintenance and service licenses. These items are contained within the FY 18-19 budget. This is scheduled for approval at the May 21 City Council meeting.
