Resolution for MFT Expenditures in 2018

At the April 16<sup>th</sup> Council Meeting, the annual resolution for Motor Fuel Tax Expenditures was presented and adopted for the current calendar year of 2018. This resolution was for \$750,000 of anticipated expenditures, however it has traditionally been adopted as a calendar year performance period of January 1 through December 31 even though the City's Fiscal Year is May 1 through April 30.

IDOT has recommended that a modified resolution be adopted at the previous resolution amount, but update the performance period to that of our Fiscal Year rather than a Calendar Year.

As such it is recommended that a resolution in the same amount of \$750,000 be adopted for this Fiscal Year.

This matter is being placed on the Council's agenda for review and action at the meeting of September 17<sup>th</sup>, 2018.
