Timekeeping Solution for Payroll

As discussed with the Finance & Personnel Committee at its last meeting, the Police Department was interested in finding a solution for electronic timekeeping that would also allow for shift scheduling. Working in conjunction with Jeremie from Clifton, they found a solution that is compatible with our current payroll system — MSI under the Harris umbrella and is actually offered as a third-party product. After several demos, Public Works and Finance/Administration are also interested in taking advantage of the advanced technology which offers multiple benefits including replacement of paper timesheets with a computer and/or smart phone portal, electronic entry and review by managers, leave request and approval, benefit accrual and determination of available balances, automatic calculation of overtime, ability to track time by job code, comprehensive reporting function, and advanced scheduling features just to name a few. The software is customizable and can be tailored to the needs of the department and employee. It is very user friendly and intuitive and can be used as simply or complex as we desire. Best of all and most critical is the ease of integration with our current system which will allow for the most streamlined and efficient approach for payroll processing.

Attached is a quote received by Harris for a total cost of \$21,625.23. This includes the software licensing as well as professional services for project management, training, configuration and implementation. An optional quote was also received for a \$1,500 annual fee for hosting as our current server does not meet the required specifications. Replacement of the server is a FY 2018-19 budgeted item and thus the new server will include the required specifications and as such, hosting should not be necessary.

This is an unbudgeted expense, however, spreading the costs among the different funds including L/A, City Hall, Streets, Planning & Zoning, Police, Water and Sewer will result in smaller charges to the funds that I believe can be absorbed as part of contingency line items. However, it may be necessary to amend the budget for one or more line items depending on expenses for the remainder of the year and Staff will continue to monitor the need to do so during the budget process next spring.

Staff recommends approval of an expenditure for purchase of TimeClock Plus at an amount not-to-exceed \$21,625.23 plus hosting if required at a rate of \$1,500 per year. The annual maintenance and support for MSI products will also increase approximately \$2,500 due to the purchase.
