Attached is a copy of the Annual Report of Board of Managers of Glendale Cemetery for 2018. The report shows the receipts and disbursements related to a checking account and two certificates of deposit that the Board holds. Included as a disbursement is a remittance of \$308.03 as the annual earnings paid to the City of Washington.

In addition to the cash and investments included in the report, the City has funds in which to pay personnel and operating expenses and capital purchases related to the Cemetery. The cash and investment total as of February 28, 2019 approximates \$290,000.

Based on my review of the Report, I recommend the City Council, by motion, accept the Annual Report of Board of Managers of Glendale Cemetery for 2018 and the \$308.03 remittance of net earnings. This item has been placed on the consent agenda for action at the March 4, 2019 City Council meeting.
