Attached please find the Memorandum, requirements, justification and prices that were obtained for the budgeted upgrade to the Washington Police Department video system.

The quoted prices vary in difference from approximately \$36,000.00 to \$59,000.00. However, only Oberlander, the highest bidder, recommended the Salient Security Platform. After presentations by all three bidders it was evident that the system proposed by Oberlander was the system that would allow the most proficient expansion to City Hall, Legion Road and the Water Treatment Operations as well as offering viewing across the many platforms available to us...DeskTops, Laptops, Tablets and Phones.

In addition, Oberlander is a local company that offered 24 / 7 Technical support. However the most important aspect in choosing Oberlander and Salient is the fact that the Salient resolution far exceeded the others shown. For our purposes, the resolution is the most important aspect of our recommendation to select Oberlander Alarm Systems at a cost of \$ 59, 944.00, which is less than the amount budgeted.

The Police Department is a secure facility. As such, some areas warrant security video. Areas such as the Sally Port, Detention area and Booking room require video for evidentiary purposes as well as officer and detainee safety. Other areas where department personnel interact with the public also need video coverage to act as a record of those interactions. Video security also documents the entry and exit of personnel and public from HQS.

As directed by the Chief of Police, I contacted several vendors to obtain quotes for upgrading the video security system at the police department. The current system was put in place at the time of the PD Remodel in 2011, and does not meet the needs for video security that we have today.

The upgrade is needed because we have crucial "gaps", i.e. areas that need video coverage but do not currently have any.

- The front parking lot. This is designated as a meeting point for Craig's List and EBay sales. Also there are come court mandated child exchanges that take place at the police department. If something were to go wrong, we currently have no record of what transipired..
- Rear of the Police Department-The area where squad cars are parked currently has
 minimal coverage, with only a partial view of two squad cars. Damage to squad cars
 could occur now and we would have no record of it. Also, the upgrade would cover most
 of the employee parking area as well as the diesel pump in the rear lot.
- The Front Desk- The window area where the public interacts with Police Administrative Support Specialist and Officers has no video coverage.

Requirements for the upgrade:

- Additional interior cameras to cover "dead spots" such as the customer service window.
- Video coverage of the front parking lot and sidewalk
- Video Coverage of the west side of HQS and 9-1-1 Drive.
- Video coverage of parking area for squad cars.
- Video coverage of parking area for employees.
- Extended video coverage of the Sally Port Apron and City Shed area
- Minimum of 30-60 days of video storage
- Upgrade all existing cameras to current technology (4mp or 1080p)
- Upgrade of software to manage video security system
- Ability to add cameras and upgrade system capabilities as needed.

All three vendors submitted proposals. Convirgint Technologies and Liaison Home Automation recommended using ExacqVision as the software client to manage the video systems. Oberlander Alarm systems recommended Salient Security Platform as their software client. All software clients are included in the proposals. We currently have \$60,000.00 budgeted for the upgrade.

The department currently uses ExacqVision as the software client for our video system. We do not view that as a viable option for an upgrade.

It is my recommendation that we accept the proposal from Oberlander Alarm Systems. I do not view the other proposals as an upgrade, since they use the same software that we currently use. Oberlander Alarm Systems is the only proposal that truly represents an upgrade.

Washington Police Department Video Security System Upgrade

- The volume of FOIA and States Attorney requests we get is constantly increasing. Salient Security's Software would cut the time it takes to process a video request by 75%
- "Spotlight" feature of Salient Software highlights movement in unused or closed areas of a building, for example, notifying the viewer of someone entering the upper PD Hallway between 2300 0700 hours. Or City Hall when it is closed.
- Support is more accessible and easier to obtain with Salient Security Software.
