Adopt resl, amending Personnel Manual Mayor Manier read a resolution, by title only and brief synopsis, amending the Personnel Manual of the City of Washington, Tazewell County, Illinois, by revising Article X Attendance and Leave. Adoption of this resolution would amend the City's Personnel Manual by adding the text of a previously designated paid holiday in 2005 for non-union personnel (Martin Luther King, Jr. Day) and designate Good Friday as a paid holiday for non-union personnel. Budget Review: Water and Related Funds

Controller Baxter provided an overview of the following water and related funds: Water Fund with a projected balance at FYE 4/30/2020 of \$470,917 compared to a minimum standard balance of \$437,750; Water Subdivision Development Fee with a projected balance at FYE 4/30/2020 of \$298,445; Water Connection Fee with a projected balance at FYE 4/30/2020 of \$771,965; and Water Tank Reserve with a projected balance at FYE 4/30/2020 of \$52,791.

## Special Washington City Council Meeting March 25, 2019

### Subject: Document titled "Budget Review - Water and Related Funds"

Thank you to the City Council of Washington for your work efforts to establish a fair and balanced budget across the dozens of separate funds required in municipal accounting – and to do this complex work in an open and transparent manner.

We especially appreciate the top-level summary "Budget Review" document provided to help us understand each major category of the budget.

We are surprised by the "Budget Review" document for tonight's discussion.... because it does NOT include reference to implementation of a revised and improved water rate structure.

We understood that the \$25,000 that was requested for the consultant would result in a proposed new water rate structure that would incentivize those that use unusually large amounts of water to implement technologies to reduce their water use. Significant reduction in water use could potentially eliminate or delay the requirement for the third water tower.

We understood that the consultant would deliver a valid, vetted proposal based on successful experiences of other municipalities across the nation. We are disappointed to see no mention of implementation of a revised and improved water rate structure in the budget for FY19-20.
