SUBJECT: 19-20 Excavator Assistance Bid Review

On Wednesday, March 27, 2019, bids were opened and publicly read for excavator assistance when City crews are not able to meet deadlines due to unforeseeable circumstances. Bid documents were forwarded to five prospective bidders and three bids were received, however there was a challenge by the Laborer's Union regarding prevailing wage and under advice from the City's Attorney, and my decision, the Excavator Assistance Bid was put back out for rebid with the Prevailing Wage Act included as part of the bid document.

The rebid document was advertised on April 17, 2019 with the bid opening on May 1, 2019. Again, bids were forwarded to five prospective bidders with one bid being received. The results of this bid are below.
