Staff is in receipt of an invoice from ESRI for the payment of the annual ArcGIS maintenance and service licenses. These include:

- ArcGIS Desktop Advanced Concurrent Use Primary Maintenance: \$3,000
- ArcGIS Desktop Basic Single Use Primary Maintenance: \$400
- ArcGIS Online Viewer (Formerly Named User Level 1) Term License Includes 10 Users: \$1,000
- ArcGIS Online Creator (Formerly Level 2 Named User Term License Includes 5 Users and 2,500 Service Credits: \$2,500

Our annual term with ESRI begins on July 13 and runs through July 12. Staff seeks authorization to make payment to ESRI in a not-to-exceed amount of \$6,900 for the annual GIS maintenance and service licenses.
