A RESOLUTION AFFECTING CHAPTER 112 OF THE CODE OF ORDINANCES OF THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS, ENTITLED "ALCOHOLIC BEVERAGES," BY ALLOWING FOR THE RETAIL SALE, POSSESSION, AND CONSUMPTION OF BEER AND WINE AT A CERTAIN BICENTENNIAL-RELATED CELEBRATION ON JUNE 15, 2019

WHEREAS, the City Code of Ordinances at Chapter 112 provides for regulation of alcoholic beverages and related licensing; and

WHEREAS, The City of Washington supports the work of the Bicentennial Committee in preparation for the City's ultimate Bicentennial Celebration, and

WHEREAS, The Bicentennial Committee has planned a fundraising dinner to support their further efforts, and

WHEREAS, it is deemed to be in the interest of the City to allow fruition of the Bicentennial Committee plan to include the sale of beer and wine at its planned fundraising dinner:

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WASHINGTON, IL HEREBY RESOLVES AS FOLLOWS:

Section 1. That the Liquor Commissioner may issue a temporary event license to a holder of current Class A liquor license, issued by the City of Washington, for the area of the event described below and otherwise in accordance with the requirements for a Class L license.

Section 2. That on June 15, 2019, from 4:00 P.M. until 8:00 P.M., event participants may possess and consume beer and wine otherwise in accordance with the City Code and the retailer licensed for the event may possess and offer for sale beer and wine otherwise in accordance with the City Code. That the retailer licensed for the event may possess beer and wine within the event area for up to two hours beyond the public event times in order to set up and tear down its temporary facility on the same day as the event.

Section 3. That the special area for this event includes the public way along South Main Street from its intersection with, but not including, Washington Square (U.S. Business Route 24) on the north to its intersection with Burton Street on the south, may also include the north parking lot at 130 South Main Street from a north/south line parallel to the eastern boundary of the public way on the property commonly known as 106 Peoria Street on the west to South Main Street on the east, and may also include the property commonly known as 104 Washington Square.

Section 4. That all ordinances, or parts thereof, in conflict herewith are hereby expressly suspended within the special area for the time period described in Section 2.

Section 5. That this resolution shall be in full force and effect from and after its passage and approval as provided by law, and shall sunset on June 16, 2019.
