Property and Liability Insurance Renewal

Dennis Hermann from Alexander Murray Agency presented the renewal proposals for the property and liability insurance for plan year July 1, 2019 through June 30, 2020 at the Committee of the Whole meeting on June 10, 2019. As indicated, the low bid was received from Tokio Marine/HCC at a total premium of \$135,574, which is a \$20,986 savings compared to the current policy and \$37,173 less than the next lowest bid from the incumbent, Traveler's Insurance.

HCC provided insurance during the 2013 tornado and Staff was pleased overall with the services provided. In addition, the company has an A+ rating by AM Best.

Staff recommends acceptance of the proposal from Tokio Marine/HCC at a total premium of \$135,574.

City of Washington, Property & Liability Coverage Proposals

For July 1, 2019 to July 1, 2020 term

On June 4, 2019 we received proposals from three insurance providers based on a Request for Proposals (RFP) and specifications issued by Alexander Murray Agency on April 9, 2019. Said RFP and specification was substantial based on the existing coverage currently provided by Travelers Insurance other than some updates on the schedule of property adding items and increasing valuations.

Attached, find a tabulation of the three proposals we received. We find each of the proposals to be substantially responsive to the RFP and specifications. The low proposal is from Burnham & Flower/Tokio Marine-HCC at a total estimated premium of \$135,574. Due to a minor change on the auto schedule of values that I am making to update a valuation we received after the schedule was released to bidders, the final premium amount could be slightly higher. The City was previously insured through Burnham & Flower from April 1, 2013 thru July 1, 2016 during which time they handled a significant property claim for tornado damage at WWTP #2. The current term premium with Travelers is \$156,560. Burnham & Flower quote is therefore a savings to the City of \$20,986 compared to prior term, or roughly a 13.4% decrease. This is a very very good offering.

Full details on the coverages are provided in the proposal which is included in your agenda.

It is our recommendation to accept the proposal from Burnham & Flower for the term July 1, 2019 thru July 1, 2020 for \$135,574.

I want to thank the Mayor and Council for the opportunity to again present an offering for coverage renewal. And I would also like to thank City staff including, Joanie, Ed, Kevin, and Jeff for their time to help accumulate details for this proposal process.
