AN ORDINANCE CORRECTING AN ERROR IN EXHIBIT A OF ORDINANCE 3342 ENTITLED “PROPOSING THE ESTABLISHMENT OF SPECIAL SERVICE AREA NUMBER 2 IN THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS, THE LEVY OF TAXES, AND SETTING A DATE AND PROVIDING NOTICE FOR A RELATED PUBLIC HEARING”

WHEREAS, Ordinance No. 3342 was passed by the City Council of the City of Washington, Illinois, on September 3, 2019, proposing the establishment of a special service area to finance certain improvements, infrastructure and facilities constituting special services, including, but not limited to, installation and/or maintenance of sanitary lateral, sump line, and water service improvements within a part of the City located along N. Lawndale Ave (the “**Ordinance**”); and

WHEREAS, Exhibit A of the Ordinance lists all the affected properties to be included within the proposed special service area and was found to be missing the ID Number and common street address for two affected properties, namely the properties having the common street addresses within the City as 501 N Lawndale Ave and 425 N Lawndale Ave (the “**Affected Properties**”).

WHEREAS, the Affected Properties were included in Exhibit B and Exhibit C to the Ordinance and were originally intended to be included within the proposed special service area as set forth in the Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS, as follows:

Section 1. That Exhibit A of Ordinance 3342 be amended to read as follows:
