Explanation: The nature of roadway repairs under the annual Motor Fuel Tax (MFT) improvements includes items that IDOT would not consider part of a typical maintenance program. The proposed improvements are similar in nature to the FY16/17 program whereby 3' edge milling is done along the deteriorated edge of pavements and curb lines. **Additional documentation attached.**

Fiscal Impact: These are budgeted expenses using IDOT Motor Fuel Tax (MFT) funds in the total amount of \$900,000.
