Agenda Item: Budget Review Follow Up

Explanation: I provided the City Council my Budget Memo on Monday, January 13th which provided the method that I will be using to review the Department Director's Budget requests and the schedule we intend to bring it to the City Council. Joanie and I have further discussed the schedule and have made some changes such that all General and related funds will be completed with Group 3 and a preliminary General Fund budget will be available for Council discussion on March 2nd. This will give us an opportunity to fully vet the General Funds and Revenue projections earlier in the process and allow us to be better prepared to discuss any Capital Improvement Projects knowing what our operations costs and surplus funds are estimated to be.

Please be prepared to give me any feedback that you have related to the process and schedule. It is my hope to have any new personnel requests and expanded level service requests on the February 10th Committee of the Whole meeting. It is also my intention to have the total revenue estimate at the same meeting so that the Council will have an idea of the total available funds for budget decisions.
