# AN ORDINANCE AUTHORIZING THE DONATION AND/OR SALE OF VARIOUS UNCLAIMED PROPERTY POSSESSED BY THE WASHINGTON POLICE DEPARTMENT DESIGNATED AS "SURPLUS PROPERTY"

**WHEREAS**, on the 6<sup>th</sup> day of April, 2020, the corporate authorities did, by no less than a three-fourths vote thereof, declare the personal property identified on Exhibit "1" attached hereto, and by reference expressly made a part hereof, to be "surplus property" as same was no longer necessary or useful to the City of Washington in its operations or in the performance of its programs or services; and
