**Agenda Item:** Resolution – Bid Award: PW-20-04 Softener Salt

**Explanation**: On Wednesday, April 8, 2020, bids were opened and publicly read for the City's purchase and delivery of approximately 1,250 tons of Industrial Grade Water Softener Salt for use at the City's Water Treatment Plants. Bid documents were forwarded to six prospective suppliers and two proposals were received. The following are the results of this effort.

**Fiscal Impact**: \$120,000 in FY 20/21, salt purchases over the last 3 years has averaged approximately \$108,000.

## Recommendation/

**Committee Discussion Summary:** The above price compares to last year's awarded unit price of \$109.50/Ton, which represents a 2.67% increase in cost.

Based on the above, the fact that Gunther has provided good service and product during salt shortages in the industry, and because the City has a history with Gunther and not Midwest Salt LLC, it is recommended that the City Council award the bid for the City's purchase and delivery of Industrial Grade Coarse Water Softener Salt for FY 20-21 to Gunther Salt of St. Louis Missouri at a unit price of \$112.50/ton.
