Synopsis: Adoption of this ordinance would correct a calculation error in the pricing table, amend the pricing table to include a fee for landscape waste drop-off, and include access to the Contractor's landscape waste facility.

AN ORDINANCE AMENDING AND CORRECTING AN ERROR IN THE PRICING TABLE OF ORDINANCE 3368 ENTITLED "AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS, TO EXECUTE A RESIDENTIAL SOLID WASTE CONTRACT WITH PDC SERVICES, INC., AN ILLINOIS CORPORATION FOR THE PERIOD APRIL 1, 2020 THROUGH MARCH 31, 2027"

WHEREAS, Ordinance No. 3368 was passed by the City Council of the City of Washington, Illinois, on March 2, 2020, authorizing a residential solid waste contract with PDC Services, Inc.; and

WHEREAS, Item 4 (F) entitled "Pricing" included a pricing table with a calculation error in the Basic Service fee for contract option periods 4/1/27-3/31/28, 4/1/28-3/31/29, and 4/1/29-3/31/30; and

WHEREAS, it is in the best interest of the City and its residents to have an option for a drop off location for landscape waste for those who only produce a small amount of landscape waste.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS, as follows:

Section 1. That Item 4 (E) entitled "Access to E-Waste Drop-Off Facility" is amended by deleting Item 4 (E) in its entirety and by substituting the following as Item 4 (E):

E. Access to E-Waste and Landscape Waste Drop-Off Facility.

Residents of the City may drop off televisions, computer monitors, microwaves, and other e-waste items excluded from Illinois landfills at Contractor's drop-off facility at 1090 W. Jefferson Street, Morton, Illinois, during the facility's regular business hours, subject to the rules of the facility, so long as Kuusakowski US, LLC operates its Peoria, Illinois facility. Non-residents of the City and businesses may be required to pay for use of the facility, or may be denied access to the facility.

Residents of the City may drop off landscape waste at Contractors drop-off facility at 1090 W. Jefferson Street, Morton, Illinois, during the facility's regular business hours, subject to the rules of the facility. The fee for drop-off is as indicated in the pricing table in Item 4 (F). Non-residents of the City and businesses will not be allowed the use of the facility for landscape waste.

Section 2. That the table in Item 4 (F) entitled "Pricing" be amended and corrected to read as follows:
