Agenda Item: Water Treatment Plant #1 Filter and Softener Rehabilitation.

Explanation: Last year Water Treatment Plant #1 started the rehab process of its Iron Filters and Water Softeners, getting one of each done. There are 4 Iron Filters and 3 Water Softeners that still need to done. We would like to start the process and make sure we can get Evoqua scheduled for this fall to finish the rehabilitation.

Fiscal Impact: Evoqua has quoted the project at \$258,064.26 for the cleaning and disposal of old media, purchase and delivery of media and resin, checking metal integrity, and installation of media and resin for 4 filters and 3 softeners. The City has a Planned Expenditure of \$350,000 (Acct# 500-00-800-3000) for this work.


Recommendation/
