**Agenda Item:** Sanitary Sewer Lining-St. Marks

**Explanation:** On April 20, 2020 Council approved Hoerr Construction as the provider of cured in place piping through the commodities bidding.

During investigating the sanitary sewers in support of the West Holland reconstruction project an 18" pipe was found in need of lining. This pipe is 188' long and the condition of the pipe was discovered when crews were installing a manhole to make televising and cleaning possible.

Hoerr Construction was contacted for pricing with results for the project coming in at \$18,560.00.

**Fiscal Impact:** \$18,560.00 of the \$150,000 budgeted in account number 501-00-800-3000

**Committee Discussion Summary:** Staff recommends Hoerr Construction for lining of the 18" sanitary pipe under the St. Marks parking lot between S. Main and S. Market to prevent or reduce failure.
