**Agenda Item:** Lawndale Engineering Overages

**Explanation:** Mohr and Kerr was the design engineer selected to do the design for both the Holland and Lawndale private Utility Contracts. Upon my starting here, I had reached out to each of the consultants we had on contract for design to discuss where their contracts were. John Anderson had done this before I was here as well. Mohr and Kerr was hesitant to ask for more money as they felt it might hinder their chance to get future work with the City. I feel that there should be honest pay for overages that are caused by our own actions.

Mohr and Kerr submitted a breakdown of charges for overages for both Holland and Lawndale that totaled over \$30,000 of which I believe almost half are directly related to changes that arose while I have been here. The changes in the design contract are due to the condition of the rear yard sewers and their inclusion into the projects, and the easement documentation required for them. The condition was not known before the project begun and was not initially scoped into the work.

The overage on the Lawndale project is shown at \$14,884.

**Fiscal Impact:** This additional is not budgeted for but there are sufficient funds in Account # 501-000-800-3000 to cover this additional expense.

**Recommendation Summary:** The design work has been completed and staff recommends payment to Mohr and Kerr in the amount of \$14,884.
