Agenda Item: Website Updates and Considerations

Explanation:

This item was included in the Budget Overview and Requests for the 2021/2022 Budget at the January 19th Finance & Personnel Committee Meeting.

The City's website was updated several years ago and it was consistent at the time with those of other municipal websites throughout the country. Many technological and design improvements have been made in the industry and staff would like to do a major website update. The website is a key tool used by staff, residents, visitors and private developers to gather information on the City of Washington and historical and legal information. A well-maintained and updated website is essential in providing transparency and meeting Open Meeting Act requirements for public meetings. Staff has received a proposal from the current website host and developer at a cost of \$10,500. This item could be undertaken this fiscal year with existing funds should the Committee wish Staff to pursue this option.

Fiscal Impact: \$10,500 for FY 2020/2021 with a \$1,000 discount in the 2021 annual support and maintenance invoice. Funds are available in the Budget from expenditures held back in the COVID-19 Response Plan as well as from unbudgeted increased revenue. Specific line items will be included in a memo which will be drafted and presented to the City Council should the Committee of the Whole Recommend this project.

The result of the redesign will be a website that is more contemporary in its design, is better organized, and better accommodates mobile devices using responsive design technology. Responsive design is a web design approach aimed at crafting sites to provide an optimal viewing experience—easy reading and navigation with a minimum of resizing, panning, and scrolling—across a wide range of devices (from mobile phones to desktop computer monitors). With additional features that include Smart Search, Meetings Landing Page.

eGov will work with the City to plan and implement the design and content changes not to exceed the hours listed below.
