Agenda Item: Bid Award – Hilldale Reconstruction

Explanation: Staff solicited bids for the reconstruction of Hilldale from Terrace to Lawndale. The existing roadway is asphalt/chip seal with the proposed road surface to be constructed as asphalt/concrete. Contractors were allowed to offer alternate bids to compare asphalt and concrete pavement prices. This project will also include the placement of new watermain, sanitary sewer, curb and gutter, sidewalk, and a sump drain lines.

A bid opening took place on April 1 at Hutchison's office via ZOOM with five bids submitted.
