Agenda Item: Purchase Authorization Concrete Assistance

Explanation: Council will remember approving Lonewolf Concrete for Concrete Assistance last Spring when City crews were unable to perform needed work due to the scope of the project or when work schedules did not allow for crews to complete the work. The FY 20/21 budget allowed for improvements to the Legion Road Facility and as such Lonewolf was contacted to perform concrete work at that location. This work included concrete approaches and paving on the west portion of the parking lot.

Fiscal Impact: \$78,130.00 from account # 100-003-800-2000. There is \$125,000 budgeted for this work as well as other improvements and there are sufficient funds available.

Committee Discussion Summary: Lonewolf has completed other work for the City with satisfactory results. They are the contractor of choice through the City's commodity bidding and as such staff recommends approving the work that has been completed.
