Call to Order Mayor Manier called the special meeting of Monday, May 10, 2021 to order at 6:30

p.m. in a banquet room at Five Points, Washington, 360 N. Wilmore Road,

Agenda Review The Agenda was reviewed and stood as presented.

Approve Consent Agenda Mayor Manier presented the Consent Agenda for approval of the following items:

a) Approval of minutes of April 28, 2021 Special City Council Meeting

Announcements and Proclamations

Swearing in of New Police Sergeant, Ryan Hunsinger; Police Chief Mike McCoy shared that Officer Hunsinger has been with the police department for 15 years and was the first pick of the selection committee. Chief McCoy then provided the swearing in of Sergeant Hunsinger followed by the placement of his pin by his wife and family. Sergeant Hunsinger thanked his family, friends, wife, Council, Mayor, and Deputy Chief. He shared that he was happy with his current position but wanted to apply for Sergeant due to the leadership of Chief McCoy. Sergeant Hunsinger shared that the Chief leads by example and is a mentor to those in the department.

Mayor Manier asked retiring Sergeant Gordon and Retiring Officer Henderson to step forward for recognition. Sergeant Gordon shared that he has worked with the department for 22 years and under seven chiefs and acknowledged Chief McCoy as the best to work for, as well as Deputy Chief Stevens. Officer Henderson shared that he has been with the department for 27 years and stated that it has been an honor to serve the community and all of the department.

Audience Comments

-Dan Leman provided the comment that there was a discussion online concerning Chief McCoy or his wife donating to the Mayor's campaign. He assumed that all proper rules were followed but asked what safeguards are in place to address ethics issues that may arise while the Mayor is acting City Administrator and Police Supervisor.

-Doug Brod provided the comment that he is an advocate for police due to a family history of his dad being a police officer for 30 years in the Village of Oak Park, west of Chicago. He attributed his own success due to the support his dad received from the department and village, as a police officer. He stated that the Council has a responsibility to make sure the children of the officer and the officer are safe. He stated the resource to keep them safe is Chief McCoy. He stated that Chief McCoy's contacts and resources make our city safer and Council has the responsibility to the officers and community to provide safety. He also noted that the officers are the ones putting their life on the line.

-City Clerk Brod noted that she sent the public comments provided at the last meeting to Council for a second time.

Standing Committee-Finance & Personnel Committee

Chairman Daniel Cobb, Finance & Personnel Committee, shared that there are no agenda items this evening.

Standing Committee-Public Safety Committee

Chairman Brian Butler, Public Safety Committee, shared that there are no agenda items this evening and introduced Police Chief McCoy who share a brief update stating the Council and committee members were sent a monthly report and he could be contacted with any questions. He shared that no concerns or questions were received.

Standing Committee-Public Works Committee

Chairman Mike Brownfield, Public Works Committee, noted that there is one item on the agenda and introduced City Engineer Dennis Carr to provide details about the MFT Bid Awards that took place earlier in the morning. Mr. Carr shared that this was pushed back a week due to the lack of availability of product. Mr. Carr shared that they found a local source for the product and they had three bidders for the spray patch, one bidder for the fog-coat and one bidder for the asphalt and overlay. Mr. Carr shared that D&D Sweeping was the low bidder for spray patch, at \$20,000 over estimates, RA Cullinan was the low bidder for seal-coat at \$100 under budget, fog-coat at \$60,000 under budget, and asphalt at \$17,000 over expected. Mr. Carr stated that IDOT authorized \$1 million in spending for this project and these sections are estimated at \$952,746.18. Mr. Carr noted that Shelbark and Pinetree will need to be removed from this project so that they can received more attention, due to an unfriendly winter.

Alderman Brownfield motioned and Alderman Adams seconded to approve the D&D Sweeping bid for \$182,260

Alderman Dingledine asked why there is discrepancy in the estimates. Mr. Carr noted the increase in oil prices.

Engineer Carr shared that Bobolink is pouring concrete and landscaping is staring in a few days. He also noted that the private side is down to four homes. Mr. Carr went on to share that ICCI is coming back to grind curb on the Stratford Bridge.
