Agenda Item: Section 5310 Transportation Grant Program Local Funding Contribution Consideration

Explanation:

The Tri-County Regional Planning Commission (TCRPC) currently has a call for projects for the Federal Transit Administration's Section 5310: Enhanced Mobility of Seniors & Individuals with Disabilities federal grant program. There is up to \$316,461.85 of federal grant funding available for projects that meet the goals of the Section 5310 program, which are to assist communities in meeting the transportation need of individuals with disabilities and older adults when the transportation service already provided is unavailable, insufficient, or inappropriate to meeting these needs. Applications are due to TCRPC by October 1.

Washington Township started a program within the last couple of years to provide free ride service to "mobile seniors" within the 61571 zip code. Much of Washington and Morton have been found to be within a mobility "grey area" where there is little to no alternative means of available motorized transportation. CityLink has proposed applying for this grant to establish a trial program for up to 12 months that would extend the Township's program to provide disability shuttle service from Washington to points primarily in Peoria and East Peoria that figure to have the highest demand. The 5310 program funds capital costs at a minimum 80/20 level while operating costs are funded at a minimum 50/50 level. The 5310 grant program specifically states that projects that fill or alleviate regional transit grey areas will be given priority when considering a decrease in local cost share requirements. The intention for this grant would be to apply for funds to assist with the operations.

The call for projects announcement letter is attached. Also attached is the Township's program brochure and senior/disability population statistics from the 2016 Heart of Illinois Human Services Transportation Plan.

Fiscal Impact: The FY 21-22 budget does not include any funding to be used towards transit improvements or grant contributions. While a total project estimate is still being developed by CityLink at the time of this writing, the Township has asked about the City's willingness to contribute up to \$50,000 as part of a local cost share with the Township also providing up to \$50,000. This would assume a total project cost of no more than \$200,000 to establish a disability shuttle service trial program that uses the Township's current program as a base. Funds that the City will receive as part of the American Rescue Plan Act may be able to be used towards this, though staff would need to investigate that in more detail should there be interest in participating in part of the local cost share.

Action Requested: Staff requests direction on whether there is interest in participating in a local cost share with Washington Township on this grant application. This is scheduled for consideration by the entire Council given the need to provide direction prior to the grant deadline on October 1.

Re: Section 5310: Enhanced Mobility of Seniors and Individuals with Disabilities

Dear HSTP Region 5 partner:

Tri-County Regional Planning Commission (TCRPC) is opening a call for projects for the Section 5310: Enhanced Mobility of Seniors & Individuals with Disabilities federal grant program.

There is up to \$316,461.85 of federal grant funding available for projects that meet the goals of the Section 5310 grant program¹. TCRPC encourages each of your respective organizations to openly investigate all projects which may be eligible for the funds.

Program Goals:

The goal of the Section 5310 grant program is to assist communities in meeting the transportation needs of individuals with disabilities and older adults when the transportation service already provided is unavailable, insufficient, or inappropriate to meeting these needs.

Eligible Applicants:

Private non-profit organizations, state and local government authorities, and operators of public transportation services that provide transportation services within the Peoria-Pekin urbanized area are eligible to receive Section 5310 funding.

Eligible Activities:

Section 5310 program funds are available for **capital and operating expenses** that support the provision of transportation services to meet the specific needs of seniors and individuals with disabilities.

Examples of eligible activities include2:

- Acquisition of expansion or replacement buses or vans³
- Vehicle rehabilitation
- Preventive maintenance
- Radios and communication equipment
- Vehicle wheelchair lifts, ramps, and securement devices
- · Purchase and installation of benches, shelters, and other passenger amenities
- Computer hardware and software
- ITS (Intelligent Transportation Systems)

- Dispatch systems
- Fare collection systems
- Coordinating individualized travel training and trip planning activities for customers
- Developing a one-stop transportation traveler call center
- Expansion of paratransit service parameters beyond the three-fourths mile required by the ADA
- Expansion of current hours of operation for ADA paratransit services that are beyond those provided on the fixed-route services
- Providing escorts or assisting riders through the door of their destination
- Building an accessible path to a bus stop that is currently inaccessible, including curb cuts, sidewalks, and accessible pedestrian signals
- Improving signage or wayfinding technology
- Supporting administration and expenses related to voucher programs for transportation services offered by human service providers
- Supporting volunteer driver and aide programs

Local Matching Requirements:

Capital and mobility management costs are funded at *a minimum of* 80/20 federal to local match. Operating costs are funded at *a minimum of* 50/50 federal to local match. A limited amount of this funding is approved for up to 100% federal share.

The determination of federal share for each project will be made by the project decision team. Please apply for these funds under the assumption that if selected, your project will require the minimum local match requirement.

Funding Breakdown:

There is \$316,461.85 of total funding available. These funds are a combination of three sources of 5310 funding:

- Annual apportionments from the Federal Transit Administration (FTA) for the Peoria urbanized area,
- Two COVID relief funding streams:
 - o The American Rescue Plan Act of 2021 (ARP), and
 - The Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA, pronounced "Chris-a").

Most of this available funding originates from annual FTA apportionments; these always require a local match (see Local Matching Requirements section). However, a limited amount of this funding, originating from ARP and CRRSAA, is approved for up to 100% federal share. Therefore,

highly rated, high-priority projects have the potential of receiving a higher federal share than the typical federal/local split.

Application Process & Coordination:

APPLICATIONS ARE DUE FRIDAY, October 1, 2021 AT CLOSE OF BUSINESS (4:00 p.m.).


Project Selection Process:

Once applications are received, TCRPC staff will review them for completion. Applications will be endorsed by the HSTP urban committee and scored by TCRPC staff⁴. Note that **projects that fill or alleviate regional transit Grey Areas will be given priority when considering a decrease in local cost share requirements**. Final selection is contingent upon approval from the FTA.

What is the FREE 65+ Service?

Washington Township is sponsoring FREE car ride taxi service in cooperation with Morton/Washington Taxi for 'Mobile Senior' residents age 65 and over, who live in and are traveling within Washington Townships' 61571 zip code area.

What does 'Mobile Senior' Mean?

'Mobile Senior' means seniors who are 'ambulatory', meaning those who can get in and out of a car type vehicle with little or no help from others. Canes, walkers and wheelchairs are acceptable as long as those items fold up for transportation. The cab service cannot accommodate persons with permanently attached medical devices.

The cab driver will offer some assistance to help enter and disembark the vehicle if needed. The drivers will also fold up any walker or foldup wheelchair and unfold the same items at the arrival destination.

Where can I go?

Transportation would be provided to local points <u>within</u> Washington Township 61571 that may include:

- Medical, Dental, Eyecare or Therapy
- Exercise Facilities, Library, Post Office
- Banking, Beauty Salon, Barber Shop
- Attorney, Investment or Tax Service
- Shopping, Dining, Entertainment
- Visits to family or friends within Washington Township 61571

Why This Service?

To help our senior residents, who may not have any other transportation option, to stay mobile, help meet their needs and enjoy what our community has to offer.

Are there Any Rules?

- The Free Service is available Monday through Friday, from 8am to 6pm only.
- Riders must be able to show the driver proof of 61571 Washington Township residency and 65+ age.
- The Free service is only free point to point within Washington Township 61571. If traveling outside 61571, additional rider fees would apply.
- Caretakers or family members can ride free with a qualifying senior.
- All riders will be required to read and sign a "Program Participant Release and Waiver Form", absolving Washington Township of any liability.
- As a private carrier, Morton/ Washington Taxi does not allow pets, therapy or companion animals to ride in their vehicles.
