We have included in this document all of the attachments that were presented to the Public Safety Committee on December 13, 2021 and discussed at the Committee of the Whole on December 13, 2021.

IN ADDITION TO THE PRESENTED INFORMATION WE HAVE BEEN ASKED TO DETERMINE WHAT THE YEARLY COST TO MAINTAIN THE UNITS WOULD BE. WE CAN ONLY DO AN ESTIMATE. THIS ESTIMATE INCLUDES:

TRAINING OF AN ADDITIONAL 2 OFFICERS
HELMET, UNIFORMS AND COMMUNICATION
OIL, FILTERS, FLUIDS AND CALIBRATION EVERY 5,000 MILES
TIRES AT EVERY 10,000 MILES
ANNUAL INSPECTIONS
FUEL

TAKING ALL THIS INTO CONSIDERATION, WITH AN EXPECTED LIFE OF 10 ADDITIONAL YEARS, IT IS BELIEVED THE ANNUAL COST TO BE ABOUT \$4992.31 A YEAR. (INCLUDES PURCHASE)

WE HAVE BEEN ASKED ABOUT THE NUMBER OF TIMES THE UNITS HAVE BEEN USED AND FOR WHAT OCCASIONS. WE HAVE NEVER KEPT AN ACCOUNT OF THE USAGE OR INSTANCES THEY HAVE BEEN USED. I CAN SAY THAT THE UNITS HAVE:

ESCORTED SEVERAL FUNERALS
SEVERAL PARADES
ESCORTED OTHER POLICE FUNCTIONS AS THEY HAVE COME THRU TOWN
TWO YEARS OF NATIONAL NIGHT OUT ON CRIME
MOSTLY PATROLLING THE CITY OF WASHINGTON.

THE UNITS ARE KEPT IN A SECURE HEATED FACILITY AT NO COST.

WE WILL INITIATE A DETAILED REPORT OUTLINING ALL USAGE AND EXPENSES AND WILL REPORT THAT BACK TO THE PUBLIC SAFETY COMMITTEE WHEN WE START USING THE UNITS IN THE SPRING.

In July of 2018 Washington City Council approved the Police Department to obtain bids for the lease of (2) two police Motorcycles.

Walters Brothers Harley Davidson was the low bidder of a lease program, (Attached) The Lease Agreement was for payments of \$3,500.00 a year, for each motorcycle, payable in three (3) annual installments for three (3) years. Cost to lease is \$10,500 a year for each motorcycle or total cost of \$21,000.00. (Copies of each title and lease agreement attached)

In addition to the Lease Fees, the City of Washington is responsible for all accessories and training. Total cost of such purchases is \$ 21,355.06. (See attached list)

Walters Brothers has agreed to sell the motorcycles to the City of Washington for a reduced cost of \$18,000.00 each. (Book value is \$19,660.00. (See attached letter)

We have found these motorcycle units to be a very valuable part of the Washington Police Department. Motor Unit Officers have appeared before this Committee, and the entire Council, stressing the importance they feel these units play. The motor units are used for funeral escorts, parades, public relations, speed enforcement (to a small degree) and especially recruitment. (See example attached)

As of today, the Washington Police Department has (3) three full time Officers and (1) one part time Officer as Certified Motor Unit Officers.

The Washington Police Department has received many public comments of support. The Motor Unit Officers ride through the subdivisions and spend time interacting with the youth, as well as adults, of the community...all while getting positive feedback.

We believe that with the time, training, essentials purchased and heavy interest in these units that a purchase of this price is of great value to the City of Washington.

We are asking for approval to purchase these (2) units for \$ 36,000.00.

LEASE REQUIREMENTS

This agreement made and entered into between Walters Brothers Harley-Davidson, Inc., hereinafter referred to as Lessor, and the City Of Washington Police Department, hereinafter referred to as Lessee, made this 28th day of December, 2018, for the purpose of Lessor leasing to Lessee a Harley-Davidson FLHTP police motorcycle, under the following terms and conditions:

A. Equipment

One (1) 2019 Harley-Davidson FLHTP Police Solo Motorcycle. Complete specification sheet attached for the 2019 model year.

D. Insurance

At its own expense, Lessee shall carry insurance on the motorcycle leased from Lessor in the following forms:

Lessor shall be shown on all insurance certificates as Loss Payee and Additional Insured. Lessee shall furnish to the Lessor certificates of insurance or other satisfactory evidence of the insurance coverage described herein.

Motorcycle/Auto Liability (including bodily injury liability and property damage liability) in an amount provided by the State of Illinois Auto Liability Insurance plan (\$2,000,000 per occurrence).

Motorcycle/Auto physical damage insurance (including collision, theft, and comprehensive) shall be carried in an amount sufficient to repair the equipment in the event of a loss. For the event of the total loss of the vehicle, replacement value insurance will be provided.

Lessee shall be responsible for liability for bodily injury or property damage in all events.

Lessee shall carry worker's compensation insurance covering all employees and shall assure that the motorcycle shall not be used, ridden or handled by anyone other than an employee of the Lessee. Walters Brothers Harley-Davidson will do all repairs at the regular posted rates.

E. Indemnity

The Lessee shall and does herby agree to indemnify and save the Lessor harmless from any and all liability arising out of the leasing, renting, operation, control, use, delivery, and/or return of the equipment including, but not limited to, events causing personal injury, property damage and/or death, but shall be credited with any amounts received by the Lessor with respect thereto from liability insurance secure by the Lessee. Said indemnification shall include all damages, costs, and expenses

associated with any liability or claim including attorney fees and litigation costs incurred by the Lessor as determined by a court of competent jurisdiction.

F. Liens

The Lessee shall not directly or indirectly create, incur, assume or suffer to exist any mortgage, pledge, lien, charge, encumbrance, or claim on or with respect to the equipment, except with respect to the respective rights of the Lessor as herein provided. Lessee shall promptly, at its own expense, take such actions as may be necessary to duly discharge any such mortgage, pledge, lien, charge, encumbrance, or claim if the same shall arise at any time, and such discharge shall be effective no later than the end of this lease term.

G. Taxes

The Lessee shall comply with all laws and shall pay all taxes, if any, including, but not limited to Sales and Use Taxes, Excise taxes, Personal Property Taxes and Assessments. I. Damage or Deterioration of Equipment

In the event the equipment is partially damaged or destroyed prior to the end of this agreement, the Lessee will promptly have the equipment repaired and restored to its original condition and working order for the purposes intended. All repairs shall be made at:

J. Events of Default and Remedies

Lessee shall be deemed to be in default hereunder upon the happening of any of the following events:

- A. Lessee fails to make any periodic payment, or to pay any other payments required to be paid here under, or
- B. Lessee fails to keep any such other term covenant or condition contained herein.

Upon the occurrence of an event of default as specified above, the Lessee fails to remedy such default within a period of 30 calendar days after receipt of written notice of default, Lessor or its assignees shall have the right, at its option without any further demand or notice, to pursue any one or more of the following remedies.

- A. By written notice to Lessee, Lessor may declare and amount equal to all payments due during the term of this agreement to be immediately due and payable as liquidated damages and not as penalty, whereupon the same shall become immediately due and payable;
- B. Re-enter and take possession of the equipment, enforcing this agreement or terminating this agreement, and repossess the equipment and sell or lease the equipment. Lessee shall be liable for all payments up to the effective date of such lease or sale to a third party. Lessee shall be liable for all costs, expenses, and damages incurred by the Lessor in connection with such default, including reasonable attorney fees.
- C. Take whatever action at law or in equity may appear necessary or desirable to collect the payments then due and thereafter to become due, or to enforce performance and observance of any obligation, agreement, or covenant of Lessee under this agreement.

K. Disposition of Equipment

Upon termination of this lease agreement at the end of the 36 month period, Lessee shall have the option of purchasing the motorcycle covered by this agreement for the fair market value, as determined by Lessor. In the event that Lessee does not wish to purchase the motorcycle, police officers employed by Lessee shall have the right to purchase the motorcycle at fair market value, as determined by Lessor. Said disposition will be determined immediately prior to the end of the lease period. In the event neither Lessee nor a police officer employed by Lessee purchases the motorcycle, Lessee shall return the motorcycle and all equipment to Lessor. Lessor will transfer all emergency equipment to new motorcycle purchased or leased from Lessor.

L. No Warranty

Lessor makes no warranty as to the condition of the motorcycle at the time of leasing or purchase and excludes all warranties, express or implied. Particularly, Lessor excludes all warranties as to merchantability or fitness for particular purpose. Any warranty that might apply would come directly from the manufacturer, but shall not impose any obligation on Lessor.

M. Failure to Take Possession

As a deterrent to Lessee failing to take delivery of the equipment as herein provided, Lessee agrees that if Lessee does not accept delivery, Lessee shall, at Lessor's option, forfeit to Lessor, as penalty, five

percent (5%) of the manufacture's suggested retail price of the equipment. Lessor retains the right to bring action for actual damages caused by breach of this agreement in lieu of the above penalty.

Lessee shall execute this lease and make total payment of the first 12-month lease term for a total of \$3,500.00, prior to taking delivery of the motorcycle. Total lease amount for the second and third 12-month period shall be \$3,500.00, payable 30 days prior to the beginning of the second and third respective 12-month period.
