Agenda Item: Ordinance for Intergovernmental Agreement – Tazewell County Recycling Grant

Explanation: Attached is an Intergovernmental Agreement with Tazewell County related to the award of a Recycling Grant in the amount of \$18,377.00 for CY2022. The City has received this grant for many years; however, in the prior year there was additional funding available and the requested amount of \$45,120.32 was awarded. The current year's award is more in line with past years of between \$16,000 and \$20,000.

In recent years, the majority of the grant funds have been used to fund the annual Christmas tree recycling program and offset labor and equipment used for the twice annual Brush Pick Up programs.

Fiscal Impact: A total of 18,377 in grant revenue will be received during FY22-23, representing a decrease of \$26,743 from FY21-22.

Recommendation/Committee Discussion Summary: Staff recommends approval.

**AN ORDINANCE AUTHORIZING THE MAYOR AND CITY CLERK
OF THE CITY OF WASHINGTON, TAZEWEILL COUNTY, ILLINOIS, TO
ENTER INTO AN INTERGOVERNMENTAL AGREEMENT BETWEEN
THE CITY OF WASHINGTON AND COUNTY OF TAZEWEILL FOR A
COUNTY APPROVED RECYCLING COLLECTION PROGRAM**

**BE IT ORDAINED BY THE CORPORATE AUTHORITIES OF THE CITY OF
WASHINGTON, TAZEWEILL COUNTY, ILLINOIS, as follows:**

Section 1. That the Intergovernmental Agreement between the City of Washington and the County of Tazewell for a County approved recycling collection program, a copy of which is attached hereto as Exhibit "A", and by reference expressly made a part hereof, be, and the same is hereby approved.

Section 2. That the Mayor and the City Clerk of the City of Washington be, and hereby are, authorized, empowered, and directed to enter into and execute said Intergovernmental Agreement on behalf of the City of Washington in substantially the form of the document attached hereto as Exhibit "A," and by reference expressly made a part hereof, and to make, execute, and deliver any all documents necessary for the effectiveness thereof.

Section 3. That this ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

Section 4. That all ordinances or parts thereof in conflict herewith are hereby expressly repealed.

CONTRACT

THIS AGREEMENT is entered into by and between the **CITY OF WASHINGTON** (hereinafter referred to as GRANTEE), and the COUNTY OF TAZEWELL, a body politic and corporate, (hereinafter referred to as the COUNTY).

COUNTY OBLIGATIONS

The COUNTY agrees to provide a grant in the amount of **\$18,377.00**. Payment shall be made in full and shall be authorized upon execution of this Agreement. The grant shall commence on **1/01/2022** and end on **12/31/2022**. All funds that have not been expended or legally obligated by the expiration or termination of this Agreement will have to be returned to the COUNTY within 45 days following the expiration or termination of the Agreement.

GRANTEE OBLIGATIONS

The Grantee agrees that all grant monies will be used in support of and in connection with the COUNTY approved recycling collection program. The COUNTY will monitor the recycling program to ensure it remains in compliance with the COUNTY'S IEPA approved Resource and Recovery Plan. Failure of Grantee to comply with this Plan will require forfeiture of all unused grant funds.

A midyear budget and report must be submitted by July 30, 2022, and a final project report, to be made on a form provided by the County, shall be completed and submitted no later than March 30, 2023. The reports shall provide the quantity (in pounds or tons) of waste reduced, reused or recycled, that was diverted from the waste stream.

Any modifications from the original grant application must be submitted to the County for review a minimum of 10 days prior to acting on the changes. Modification requests may be sent to mgoetze@tchd.net
