**Agenda Item:** Concrete Assistance-Bid Award

**Explanation:** On Wednesday February 2, 2022 bids were opened and publicly read for concrete assistance when city crews are not able to meet deadlines due to unforeseeable circumstances. \*The estimated quantities listed below were used for canvassing purposes only and the city is not obligated to purchase these quantities. Bid documents were forwarded to ten prospective suppliers and two proposals were received. The following is a summary of bid results.
