Explanation: Attached is the Annual Report of Board of Managers of Glendale Cemetery for 2021.

The report shows the receipts and disbursements related to a checking account and two certificates of deposit that the board holds. Included as a disbursement is a remittance

of \$85.92 as the annual earnings paid to the City of Washington.

To the best of our knowledge, at the time the cemetery became a municipal cemetery, funds existed that were held in trust and turned over to the Board of Managers. In accordance with state statute and as indicated below per 65 ILCS 5/11-52.2-1, the earnings from these funds are for the perpetual care of the cemetery:

"The principal of such trust fund shall be kept intact, and perpetually invested, and the income thereof, shall be perpetually applied for the purposes specified, in the instrument making such gift, donation or legacy and for no other purpose."

Fiscal Impact: The earnings in the amount of \$85.92 will be deposited into the Cemetery fund of the City. This fund has cash and investments totaling approximately \$150,000 in which to pay personnel and operating expenses and capital purchases related to the Cemetery.

Recommendation/Committee Discussion Summary: Staff recommends approval.
