**Agenda Item:** Resolution – FY 22-23 GIS Contract Authorization

Explanation: Staff has used the services of Cloudpoint Geospatial since September 2016. The

current agreement expires on April 30. The agreement is for a not-to-exceed total of \$62,000. Staff discussed its interest in hiring a full-time GIS employee at the February Finance & Personnel Committee meeting followed by the March 7 City Council meeting. While staff has had a very good relationship with Cloudpoint, having one employee at City Hall for eight hours per week limits the work that can be accomplished with needs from the Planning and Development, Engineering, and Public

Works departments.

A strong GIS database allows for quicker and more precise responses to questions and concerns. A well map utility system reduces costs for design, repair, and potential JULIE mismark liabilities. One key project that staff hopes to make considerable progress on in FY 22-23 is to insert easements into our GIS mapping. This is a very tedious task and even for a small section of the city, Cloudpoint estimated it would take over 300 hours to complete.

Attached is an agreement that would pay Cloudpoint at the rate of \$4,750 per month for four months plus hourly additional services up to a total of \$5,000. This four-month period would not exceed \$24,000 and is the same rate as the current agreement. Staff plans on advertising the GIS Specialist position shortly after the start of the new fiscal year on May 1. The hiring of this person would be completed by mid-summer to allow for about a one-month training and transition period with Cloudpoint before the GIS Specialist would take on the entirety of the role by August 31.

**Fiscal Impact**: The tentative FY 22-23 budget has \$26,800 included towards contracted GIS services.

This is broken down as follows: Planning/Zoning/Code Enforcement: \$10,000 and

Public Works: \$16,800.

#### Recommendation/

**Committee Discussion Summary:** Staff recommends approval of the contract with Cloudpoint. The importance of GIS across all levels of the City cannot be understated.

# AGREEMENT BETWEEN THE CITY OF WASHINGTON AND CLOUDPOINT GEOSPATIAL, INC. FOR THE PROVISION OF SERVICES RELATED TO UPDATING AND MAINTAINING THE CITY'S GEOGRAPHIC INFORMATION SYSTEM

THIS AGREEMENT is effective this	day of	, 2022, by
and between the CITY OF WASHINGTON,	an Illinois home-rule municipal	corporation ("City"),
and Cloudpoint Geospatial, Inc. ("Cloudpoin	nt").	

#### **Background**

- A. The City has established a City Geographic Information System ("GIS").
- B. The GIS requires regular maintenance and updating to be fully operational and useful to the City.
- C. The City desires to retain Cloudpoint to provide services related to maintaining and updating the GIS pursuant to the terms of this Agreement and Cloudpoint desires to provide such services pursuant to the terms of this Agreement.

#### Agreement

NOW THEREFORE, in consideration of the mutual promises, covenants and conditions herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Background</u>. The Background paragraphs set forth above are a material part of, and by this reference are expressly incorporated into, this Agreement
- 2. <u>Cloudpoint's Obligations</u>. Cloudpoint shall provide the following services to the City in a timely manner as determined by the City, depending on the particular service provided:
  - a. Provide routine GIS updates and layer maintenance consisting of adding, editing, or removing individual features from current GIS data layers, as shown in Exhibit A;
  - b. Maintenance of current ArcGIS Online web GIS applications and mobile GIS applications;
  - c. Provide on-site technical support to City Hall staff Tuesday and Thursday from 8 am-12 pm;
  - d. Provide remote technical support to City Hall staff Monday-Friday 8am-5 pm; Additional technical support and GIS work outside of regular on-site hours is billed as Additional Services;

- e. Train in-house staff on using GIS applications to empower data-driven decision making; and
- f. Other services reasonably requested by the City.
- 3. <u>City's Obligations</u>. In exchange for Cloudpoint's performance of its obligations, the City shall:
  - a. Pay Cloudpoint a base charge at the rate of \$4,750.00 per month for four (4) months; plus hourly effort against task orders as assigned by the City ("Additional Services" outside of regular on-site hours) up to an additional annual total of \$5,000.00. At the conclusion of the four (4) month period, the Client may choose to continue services on a per month basis at a rate of \$5,500.00 per month.
  - b. The City hereby agrees to pay Cloudpoint within thirty (30) days of the invoice date for services properly rendered to the City pursuant to Section 2;
  - c. Maintain and keep current all Esri software maintenance or subscription costs necessary to accomplish the tasks listed in the performance obligations; and
  - d. Maintain the necessary hardware devices to accomplish the tasks listed in the performance obligations.

#### 4. Relationship.

- a. Access. In order to permit Cloudpoint to perform its obligations under the terms of this Agreement, the City will permit Cloudpoint to have reasonable access to the City's premises, data, information, records, computers, and other materials necessary to the performance of this Agreement. Cloudpoint agrees that it will keep confidential and never divulge any knowledge or information not in the public domain which is furnished to it by the City or of which Cloudpoint becomes aware as a result of access to the City's premises, data, information, records, computers, and other materials.
- b. No Other Legal Relationship Created. Cloudpoint and the City will be and shall act as an independent contractor and not as an agent or partner of, or joint venture with, the other party for any purpose and neither party by virtue of this Agreement shall have any right, power, or authority to act or create any obligation, express or implied, on behalf of the other party.
- c. <u>Expenses</u>. Except as otherwise provided herein, or as may hereafter be established by an agreement in writing executed by the parties hereto, all expenses incurred by each party in performing its obligations hereunder shall be borne by the party incurring the expense.
- 5. Representations and Warranties of Cloudpoint. Cloudpoint has full power, and authority to enter into, deliver, and perform this Agreement and to consummate the transactions contemplated herein. Cloudpoint has duly executed and delivered this Agreement, and this Agreement constitutes Cloudpoint's valid and binding obligation, enforceable against Cloudpoint in

accordance with its terms, except as the same may be limited by bankruptcy, insolvency, reorganization, or other laws affecting the enforcement of creditors' rights generally now or hereafter in effect, and subject to the availability of equitable remedies. The execution, delivery, and performance of this Agreement by Cloudpoint and the consummation of the transactions contemplated herein, do not and will not (i) require the consent, approval, authorization, order, filing, registration, or qualification of or with any court, governmental authority, or third person, except that which already has been obtained, (ii) conflict with or result in any violation of or default under any provision of any mortgage, indenture, lease, agreement or other instrument, permit, concession, grant, franchise, or license to which Cloudpoint is a party or (iii) violate any law, ordinance, rule, regulation, judgment, order, or decree applicable to Cloudpoint.

#### 6. Miscellaneous.

- a. <u>Term.</u> Unless terminated with written notice (as set forth in Section 6(g)), the Term of this Agreement shall be until August 31, 2022 and may be renewed by the parties by mutual agreement prior to or at the conclusion of the term hereof.
- b. <u>Assignment</u>. This Agreement is binding on the parties hereto and shall not be assignable or transferrable by any party hereto without the consent of the other. Nothing in this Agreement, expressed or implied, is intended to confer upon any person, other than the parties hereto, any rights or remedies under or by reason of this Agreement.
- c. <u>Binding Effect</u>. The provisions of this Agreement shall be binding upon and inure to the benefit of the parties hereto, their heirs, executors, administrators, successors and assigns.
- d. <u>Amendment and Waiver</u>. This Agreement may be amended or modified at any time and in all respects, or any provision may be waived, by an instrument in writing executed by all parties hereto.
- e. <u>Counterpart Execution</u>. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
- f. <u>Integrated Agreement</u>. This Agreement constitutes the entire agreement between the parties, and there are no agreements, understandings, restrictions, warranties or representations between the parties relating to the subject matter hereof other than those set forth herein or herein provided for, and/or attached.
- g. <u>Termination</u>. In the event the City desires termination of this Agreement, the City shall provide to Cloudpoint thirty (30) days written notice of the termination. In the event either party desires termination for cause, the terminating party shall provide to the other party fourteen (14) days written notice of the termination and reason(s) for termination. From and after delivery of any notice of termination, this Agreement, and all future obligations hereunder, except as set forth in the confidentiality provisions in Section 4(a) and other provisions as set forth in Section 6(h), shall terminate and be of no further force and effect.

- h. <u>Preservation of GIS</u>. Upon termination of this Agreement, Cloudpoint shall take all steps necessary to ensure that the City's GIS is able to be immediately updated and maintained by the City and/or a third party selected by the City.
- i. <u>Notice</u>. The notices hereinabove provided shall be deemed to be delivered when deposited in the United States mail, by certified mail, return receipt requested, postage prepaid, addressed to the party at the respective addresses set forth below, or at such other addresses as the parties may from time to time designate in writing:

- j. <u>Attorneys' Fees</u>. In the event any action or legal proceeding is commenced to enforce any provision in connection with this Agreement, the prevailing party shall be entitled to recover as part of such action or proceedings, or in a separate action brought for that purpose, reasonable attorneys' fees and court costs as may be fixed by the court.
- k. <u>Indemnification of City</u>. Cloudpoint shall save and hold the City free, harmless, and indemnified from and against any and all liability, damages, claims, causes of action and responsibility whatsoever on account of any injury to any person or damage to any property arising out of or in any way connected with Cloudpoint's services provided pursuant to, or breach of, this Agreement.
- l. <u>Insurance</u>. Cloudpoint shall maintain an errors and omissions policy in the amount of \$1,000,000.00 and shall further maintain general liability insurance for bodily injury and property damage arising directly from its negligent acts or omissions, with general limits not less than \$1,000,000.00. In addition, Cloudpoint shall maintain Cyber Security insurance coverage in an aggregate amount not less than \$1,000,000. Certificates of insurance shall be provided to the City and the City shall be named as an additional insured under the policy.
- m. <u>Separability of Provisions</u>. Each provision of this Agreement shall be considered separable; and if, for any reason, any provision or provisions herein are determined to be invalid and contrary to any existing or future law, such invalidity shall not impair the operation of or affect those portions of the Agreement which are valid.
- n. <u>Construction of Agreement</u>. Each party was or had the opportunity to be represented by legal counsel during the negotiation resulting in this Agreement and have their legal counsel review this Agreement. The parties agree that the rule of construction to the effect that any ambiguities are to be resolved against the drafting party shall not be employed in the interpretation of this Agreement.
