**Agenda Item:** Nofsinger Realignment Update

**Explanation:** Terra Engineering was previously contracted to perform Phase 1 and Phase 2 engineering for the realignment of Nofsinger Road. The project was completed in 2017 but was shelved until future funding was available. Since Terra did the original Phase 1 and Phase 2 plans, we are working with them to update the plans.

With Representative LaHood's announcement of the \$4 million Community Project funding, the plans need to be updated to conform with the newly adopted 2022 Standard Specifications for Road and Bridge Construction. IDOT has updated their specification several times since 2017, so we will have to update pay items, traffic signal information, design standards, etc. The City has adopted new drainage standards, so the storm sewer will need to be redesigned to incorporate the higher rainfall intensities.

While the City owns all of the affected property, we will need to establish the proposed ROW for the roadway to break the parcel up accordingly. When meeting with IDOT to discuss this project, IDOT said this project could take two different paths forward depending on what type of oversight is needed:

- 1. IDOT staff is submitting for Highway Safety Improvement Program (HSIP) funds. This funding comes with more in-depth IDOT oversight (similar to Freedom Parkway) and is largely why the engineering fee is higher than expected. Since Boyd Parkway is a state route, there are some extra hurdles for special waste and reprocessing post-pandemic traffic for 2022. IDOT's Local Roads Engineering was critical of their ability for an expedited review, so the project likely would land on the August state letting, which sets construction to begin in late September or October.
  - IDOT stated they are hoping to be considered for between \$1-3 million in the HSIP program. This would easily make up for the increased upfront engineering fee. IDOT does not feel it will hold up the project, but also reminded staff that the funding is not guaranteed, as HSIP is a competitive program. A response should be offered in January if the City has received any HSIP funds. Due to some of the environmental review times, Terra has already submitted for re-review of the environmental clearances.
- 2. If the project is not selected for HSIP funds, it could be moved forward on just a local letting similar to Hilldale. IDOT would not have in-depth oversight but would still review the Boyd Parkway plans. If HSIP funds are not obtained, the project would require less engineering. IDOT's plan sheet review would not take nearly as long and an earlier letting date could be set to allow for construction to begin as early as the summer.

Lastly, if the \$4 million from LaHood's office requires IDOT oversight, the engineering will require the same review as if we receive HSIP funds, but there is uncertainty on the level of oversight required at this time.

The engineering agreement is for an amount not to exceed \$143,225.50 and the consultant only gets paid for the hours and work performed. If the in depth IDOT oversite is not required, the fee will be significantly lower.

**Fiscal Impact:** Staff recommends moving the engineering agreement to the next City Council meeting for approval.
