Public Hearing

Request by Sam Miller to rezone a property on W. Jefferson Street from R-1A (single-family residential) to C-3 (service retail) and a Special Use Request to allow for light fabrication, welding, and repair use on same parcel Commissioner Burdette opened public hearing for comment at 6:32 p.m. P&D Director Oliphant provided details regarding the request by Sam Miller to rezone a property on W. Jefferson Street from R-1A (single-family residential) to C-3 (service retail) and a Special Use Request to allow for light fabrication, welding, and repair use on same parcel. Mr. Oliphant shared that Mr. Miller is first asking to rezone the property, which is about one acre. He noted a variety of zoning designations around this property which includes R-1 as well as C-2. Mr. Oliphant also shared that the Comprehensive Plan shows general commercial in this area, so this would be a good for use for the property. Staff recommends the approval, given that this business fits in currently. Sam Miller was present and shared that the lot may currently look messy due to them outgrowing it. This is why they would like to expand. Chairman Burdette closed the public hearing at 6:34 p.m.

Commissioner Milot motioned to accept the requests; Commissioner Reeder seconded.

Commissioner Milot asked for clarification regarding the need to rezone and apply for a special use at the same time. Mr. Oliphant shared that R-1A designation only allows for single-family residences and a C-3 designation allows for a number of commercial uses such as "light fabrication" which is done at Mr. Miller's current location. Commissioner Burdette clarified that the building will be on the same lot.
