Agenda Item: First Reading Ordinance – 2023 Orthophotography Project Intergovernmental Agreement

Explanation: The City of Washington has partnered in three prior orthophotography projects within Tazewell County.

The City last participated in a similar project in the spring of 2019. There has been significant cost savings by doing this as a regional project and the goal is to have the orthophotography updated every four years for the County and its municipalities. Attached is an intergovernmental agreement that the County has asked each of the participants to approve. Tazewell County along with Logan, Peoria, and Woodford Counties approved a two-project agreement in 2019 with its selected vendor, EagleView Pictometry. This has been a great partnership with Tazewell County and the other participating

municipalities.

This project would update the aerial photos from 2019. We have been asked to provide a share of the cost based on the number of improved parcels within the city limits and 1.5-mile extraterritorial planning jurisdiction. Tazewell County would incur 50% of the cost with the municipalities sharing the other 50%.

The following package is provided, as was the case in 2019: Enhanced 3-inch imagery with 4-way obliques within the incorporated portions of the County, 6-inch imagery for the unincorporated portions, and 9-inch imagery with 4-way obliques within the unincorporated portions. This also includes maintenance for the Rapid Access – Disaster Response Program, which offers post-disaster imagery 2-3 days after an event. The higher resolution from the 2019 flight allows for significant staff use by various departments. It is a necessary component of our GIS system.

Six other Tazewell cities are participating in this project: Creve Coeur, Delavan, East Peoria, Marquette Heights, Morton, and Pekin. The County has offered to pay the entire bill in advance of the project and would then send an invoice to each municipality later in 2023 in order to adequately budget for the project. Tazewell County would be the project manager and handle all of the quality control issues with the vendor. It is expected that the flight would occur this spring and the product would be delivered within 2-3 months. Payment would occur upon the completion of the project and at the time of delivery of the product. The total municipal cost for this is \$88,120.50 with Washington's share at a not-to-exceed amount of \$13,835.

Fiscal Impact: The FY 22-23 budget includes funds for the orthophotography project participation. Adequate funds

will also be included in the FY 23-24 budget, as payment would not be made until after May 1

following the completion of the project.

Action Requested: Approval of the attached ordinance to signify the City's participation in the project at a not-to exceed cost of \$13,835. A first reading ordinance is scheduled for the March 6 City Council meeting and a second reading will be scheduled for the March 20 meeting.

AN ORDINANCE AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS, TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF WASHINGTON AND COUNTY OF TAZEWELL FOR A DIGITAL ORTHOPHOTOGRAPHY PROJECT

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS, as follows:

Section 1. That the Intergovernmental Agreement between the City of Washington and the County of Tazewell for upgraded digital orthophotography, a copy of which is attached hereto as Exhibit A, and by reference expressly made a part hereof, be, and the same is hereby approved.

Section 2. That the Mayor and the City Clerk of the City of Washington be, and hereby are, authorized, empowered, and directed to enter into and execute said Intergovernmental Agreement on behalf of the City of Washington in substantially the form of the document attached hereto as Exhibit A, and by reference expressly made a part hereof, and to make, execute, and deliver any and all documents necessary for the effectiveness thereof.

Section 3. That this ordinance shall be in full force and effect from and after its passage, approval, and publication as provided by law.

Section 4. That all ordinances or parts thereof in conflict herewith are hereby expressly repealed.

INTERGOVERNMENTAL COOPERATION AGREEMENT BETWEEN THE COUNTY OF TAZEWELL AND THE CITY OF WASHINGTON, ILLINOIS

WHEREAS, the County of Tazewell, hereafter "County", is a body politic and corporate organized under the laws of the State of Illinois; and

WHEREAS, the City of Washington, Illinois, hereafter "City", is municipal corporation organized under the laws of the State of Illinois; and

WHEREAS, the City and County mutually desire to upgrade digital orthophotography; and

WHEREAS, the County previously entered into a two project agreement with Pictometry, the second aerial flight to be completed in 2023 to include all previously received deliverables; and

WHEREAS, the Intergovernmental Cooperation Act of the State of Illinois authorizes the County and the City to enter into Intergovernmental Agreements; and

WHEREAS, the County will be partnering with various municipalities to share in the cost of the digital orthophotography to include a buy up for additional services and deliverables in the total amount of \$176,241.00; and

WHEREAS, as result of partnering with other municipalities the County's share of the digital orthophotography project will be \$88,120.50; and

WHEREAS, the City has agreed to partner with the County in the orthophotography acquisition project and share in the reduced costs; and

WHEREAS, of the \$176,241.00 the City has agreed to contribute their share of the cost totaling \$13,835.00 to be paid to the County upon project completion and at the time of delivery.

NOW THEREFORE, in consideration of the mutual promises contained in this agreement the County of Tazewell, and the City of Washington, Illinois, agrees as follows:

- 1. That the foregoing is true, accurate and factual.
- 2. That should any the forgoing be found to be false, inaccurate or not factual, such finding shall have no bearing on this agreement and this agreement shall remain in full force and effect.
- 3. That the City shall reimburse the County for the City's pro-rata share of the digital orthophotogaphy based upon 6,044 improved parcels in the amount of \$13,835.00 to be paid upon project completion and at the time of delivery.
