Recap of July Let's Talk Mayor Stevens thanked Lucas Myers for hosting her July "Let's Talk Washington" event. She encouraged other business to host future events. She shared that around a dozen people have attended each meeting and it is overall positive. The August event information will be posted on the City's website.

Communication Council Report

City Administrator Interim City Administrator/City Engineer Carr opened the floor for questions. None were provided. He added that the milling and overlaying on N. Main St., started today. He explained that it is county project and we appreciate their maintenance. He shared that we will assist the township on the closure of BUS24 for bridge painting. Scott Weaver is targeting the 20-30th to clean up the bridge and apply base paint. The Historical Society will bring in mural artist and we will assist with traffic control.

> Regarding commercial grants, Planning and Zoning Director Oliphant shared that after council direction, the draft agreements were sent to city attorney who provided edits. They were then

sent to applicants. Two applicants had responded by Friday wishing to move forward as presented. He anticipates receiving the others sometime this week.

Approve Proposal for City Administrator Executive Recruitment

Finance Director Baxter shared that she reached out to Jim Arndt from Arndt Municipal Support and sent information to council for review and staff is seeking council's direction. Included in both proposals, is that Jim Arndt's services are directly related to the candidates and the collaborative approach allows staff to create a "Team Washington" which would focus on developing recruitment materials. Option A, with the traditional approach is \$23,500 and Option B, with the collaborative approach is \$19,500. She noted that we have sufficient funds and staff feels Option B leverages the talents of our staff but still uses professional services. Alderperson Ernst motioned to approve Option B; Alderperson Martin seconded. Alderperson Moss favors Option A, feeling it provides more accountability. He feels the amount of savings isn't great enough to warrant staff's involvement. He expressed concerns with the timing of hiring the new Communications Specialist. Alderperson Blundy agreed with Alderperson Moss. He expressed concern when dealing with a possible internal candidate. He fears bias can occur. He feels the outside firm should vet the candidates. He wouldn't have an issue with only advertising the position and he feels Arndt Municipal Support should handle all the negotiations. He agrees that the mayor should be involved and work with AMS. Alderperson Martin expressed concern with Alderpersons insinuating that staff can't do the task without bias. He favors Option B and feels the City would have done the items listed under Team Washington.

to Complete the Fire Repairs to the Jefferson Street Building

Purchase Authorization Public Works Director Rittenhouse explained that the City has been working with PJ Hoerr and our insurance company for the repairs. Our insurance agreed to cover up to \$340,000 for the fire repairs. PJ Hoerr estimates \$321,065 to complete the repairs and insurance has already provided \$304,000 of the total with the remainder to be provided upon completion.

Staff recommends having PJ Hoerr complete the remaining repairs at the Jefferson Street storage building.

Alderperson Smith motioned to approve; Alderperson Sluder seconded.

Alderperson Blundy requested future discussions on what other money we can put into this building to enhance its exterior.

Alderperson Blundy is not in favor of the requests from Precious Hospitality, LLC or Countryside Banquet and Catering. He feels even if a request makes it through the filters, the City still needs to be cautious. He feels these two items are maintenance items. He prefers the requests like Ben Franklin because they are a new business fixing up an old property. He further noted that Washington Plaza has changed hands and suggested reaching out to them to discuss our comprehensive plan. He also shared that the City gave Countryside \$70,000 last year and wonders about setting time restrictions like once every five years.
