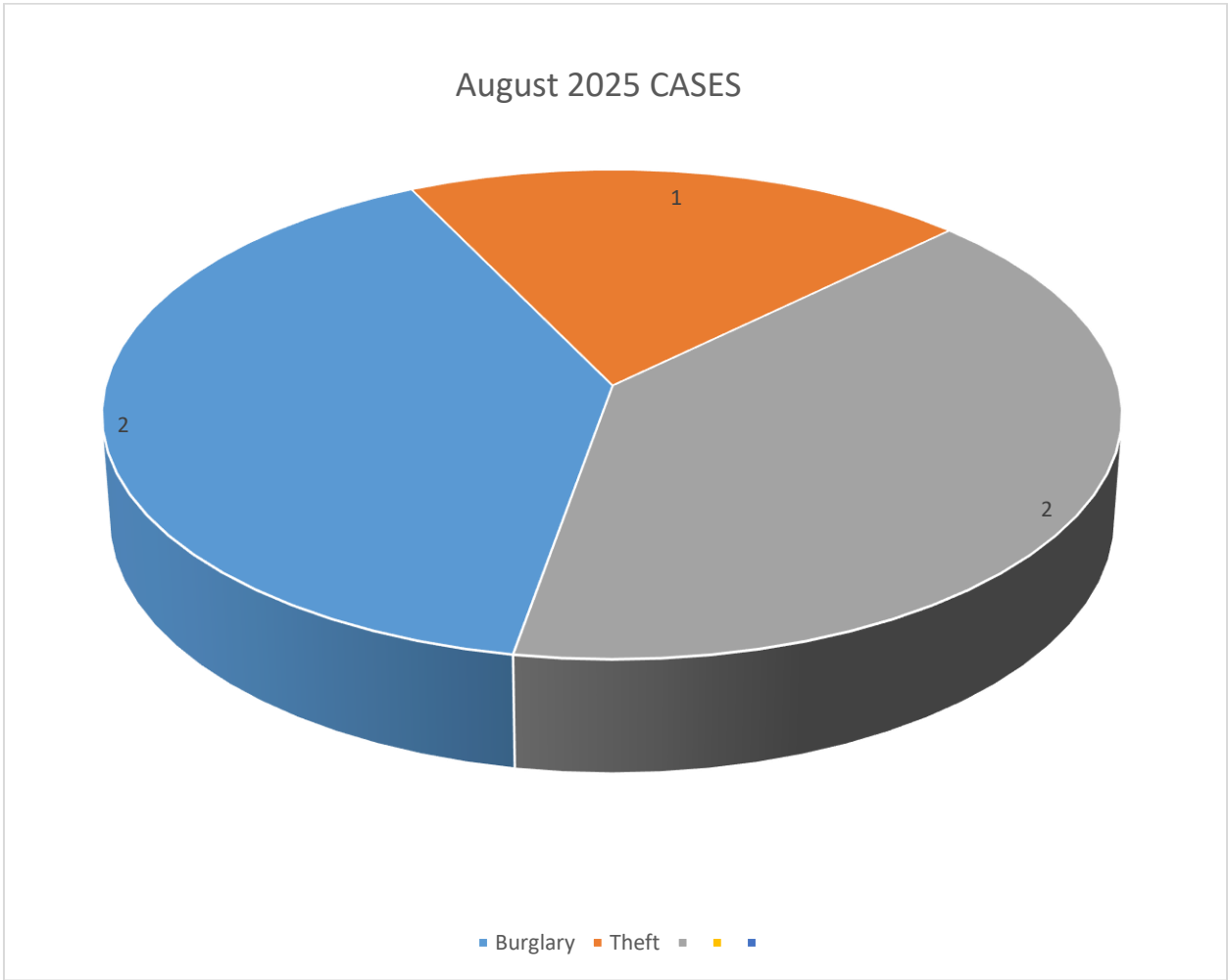

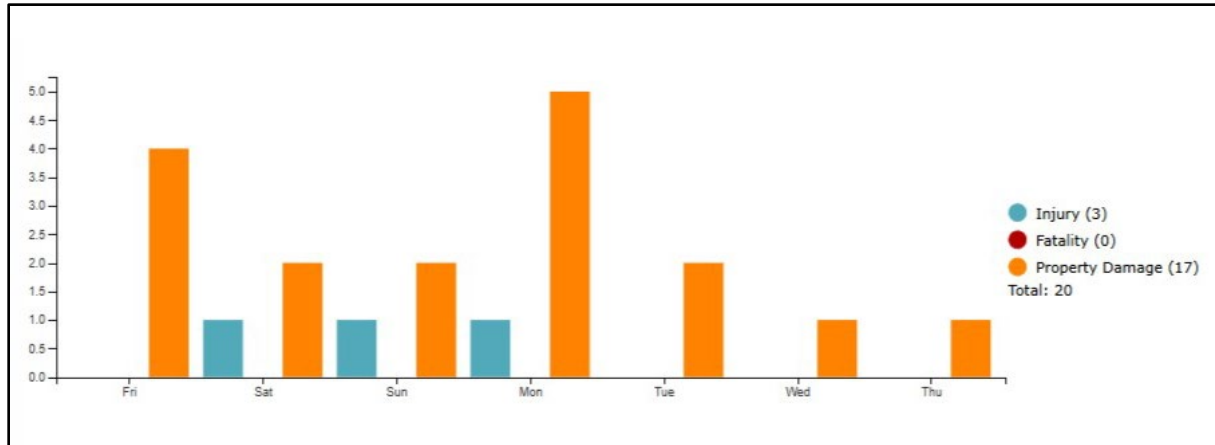
OVERVIEW FOR AUGUST 2025

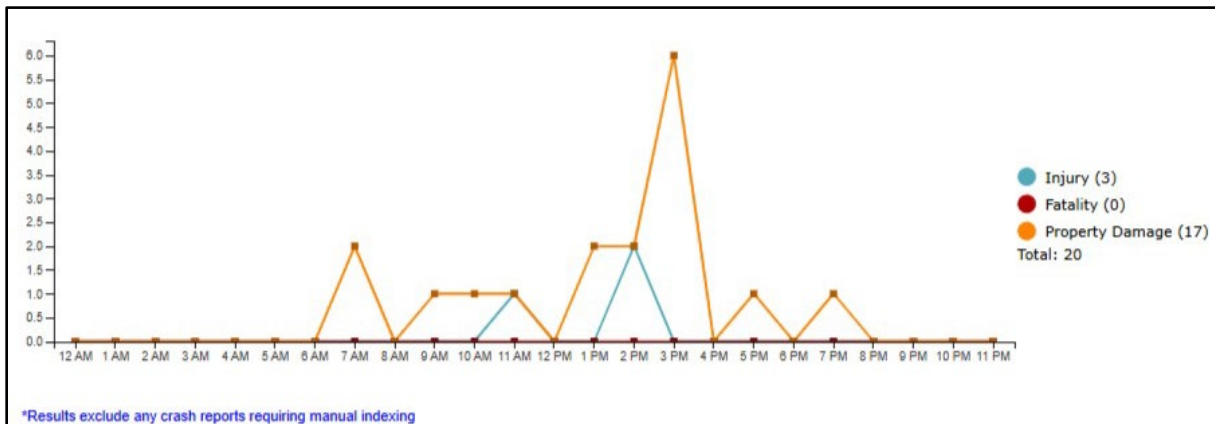
