## TRAFFIC CRASH DATA - JANUARY 2026


### Summary of Crash Data

A review of the accompanying graphics provides a clear picture of crash activity, severity, timing, and contributing conditions for the reporting period.

### Overall Severity

The majority of reported crashes resulted in property damage only, accounting for 85% of all incidents. Injury crashes made up 15%, and no fatal crashes were reported during this period.

This indicates that while crashes are occurring with some frequency, the overall severity remains relatively low.




### Monthly Distribution

Crash activity during the reviewed month totaled 20 incidents.

Property damage crashes were the predominant type, with a small number of injury-related crashes and no fatalities. This distribution reinforces the overall trend that most incidents do not result in serious physical harm.


### Time of Day

Crashes were spread throughout the day, with noticeable increases during morning and evening hours, corresponding with typical commuter traffic periods. Midday hours showed moderate activity, while overnight hours experienced minimal crash occurrences. This pattern suggests traffic volume and commuting behavior are key contributing factors.



## Day of the Week

Crash activity varied by day, with weekdays accounting for the majority of incidents. Certain days showed slightly higher concentrations of property damage crashes, while injury-related crashes remained limited and isolated. Weekend crash counts were comparatively lower.




## Weather Conditions

Most crashes occurred during clear weather conditions, representing 75% of incidents.

Cloudy or overcast conditions accounted for a smaller portion, while rain and snow each represented a minimal share.


This suggests that crashes are more closely tied to traffic volume and driver behavior than adverse weather conditions.



## Key Takeaways

- Property damage crashes overwhelmingly outnumber injury crashes.
- No fatal crashes were recorded during the period.
- Crash frequency aligns with normal traffic patterns rather than hazardous weather.
- Peak crash times correspond with commuter hours.
- Overall crash severity remains low, though continued monitoring and targeted traffic safety efforts during peak hours may help reduce incident frequency further.
