Mayor's Comments

City Administrator Forsythe requested Council approval of the FY19-20 Non-Union Pay Plans. He shared the following: a general wage increase of 2.5% was reflected in the budget for nonunion personnel; Laborer's union contractual increase for FY19-20 is 2.5%; and police are currently in negotiations as their contract is due to expire April 30, 2019. City Administrator Forsythe provided second reading of the following ordinance, by title and brief synopsis: an ordinance adopting a budget for corporate purposes for the Fiscal Year beginning May 1, 2019 and ending April 30, 2020 and approving certain amendments to the FY18-19 Budget. Adoption of this ordinance would approve the City of Washington's budget for the Fiscal Year beginning May 1, 2019 and ending on April 30, 2020 in the amount of \$29,523,402. As required by state statute, a public hearing on the city's FY19-20 Tentative Annual Budget is scheduled for 6:30 p.m. on Monday, April 8, 2019. Alderman Dingledine moved and Alderman Brownfield seconded to adopt the ordinance as read. Alderman Brownfield thanked staff for their work in preparing the budget. City Administrator Forsythe provided first reading of the following ordinance, by title and brief synopsis: an ordinance amending Chapter 136 of the Code of Ordinances of the City of Washington, Tazewell County, Illinois, entitled "Gambling Offenses," by adjusting fees for establishment video gaming licenses & terminal permits and providing for terminal operator licensing and terminal fees. Adoption of this ordinance would increase the annual terminal permit sticker fee for a Video Gaming Establishment and remove the 50% reduction of annual license fee for Class E liquor license holders. It would also add regulations for a Video Gaming Terminal Operator which include annual license and terminal permit sticker fees. Alderman Dingledine moved and Alderman Adams seconded to waive second reading and proceed with adoption of the ordinance as read. On roll call the vote was:

Adopt ord, amending Chapter 136, regarding video gaming Alderman Brownfield moved and Alderman Moss seconded to adopt the ordinance amending Chapter 136 of the Code of Ordinances of the City of Washington, Tazewell County, Illinois, entitled "Gambling Offenses," by adjusting fees for establishment video gaming licenses & terminal permits and providing for terminal operator licensing and terminal fees. There was no further discussion and on roll call the vote was:

1st reading ords, authrz TIF agreement w/Columbus Club, 120 Walnut St; amending Chapter 154; amending Section 34.04; amending Sections 50.51 & 50.55; amending Chapter 93; amending Sections 75.10A & B; and amending Sections 50.50 & 52.103 City Administrator Forsythe provided first reading of the following ordinances, by title and brief synopsis: an ordinance authorizing the Mayor and City Clerk to enter into an Agreement for Private Development with Columbus Club for the Redevelopment of a portion of the Downtown Tax Increment Redevelopment Project Area. Adoption of this ordinance would approve a TIF redevelopment agreement with Columbus Club for the redevelopment of 120 Walnut Street; an ordinance amending the Code of Ordinances of the City of Washington, Illinois by amending Chapters 154.041 entitled "Yards Required," Chapter 154.057 entitled "R-1 Districts," Chapter 154.058 entitled "R-2 Districts," Chapter 154.075 entitled "Yards Required," Chapter 154.303 entitled "Permit Required," and Chapter 154.731 entitled "Compliance with Building Code." Adoption of this ordinance would require a five-foot setback for driveways in residential districts and the AG-1 district, require an annual renewal of a home occupation permit, and require that all solar energy systems be installed by a trained and qualified solar installer; an ordinance amending Chapter 34.04 entitled "Chief of Police; Appointment; Removal; Responsibilities" of the City of Washington Code of Ordinances. Adoption of this ordinance would allow for the appointment of the Chief of Police to serve as Director of Public Safety; an ordinance amending the Code of Ordinances of the City of Washington, Illinois, by amending

Section 50.51 entitled "Deposits" and 50.55 entitled "Failure to Pay Charges; Proceedings." Adoption of this ordinance would increase the water account deposit from \$100 to \$125 and increase the restoration fee for a water service that has been shut off from \$50 to \$75 during hours and from \$100 to \$150 after hours; an ordinance amending Chapter 93 of the Code of Ordinances of the City of Washington, Illinois, entitled "Fire Prevention", by adjusting open burning requirements, requiring some permits, and reducing allowable times for burning landscape waste. Adoption of this ordinance would limit the times of landscape waste burning, protect recreational fires, provide rules limiting noxious smoke, require permits for fires larger than recreational fires, and prohibit smoldering fires; an ordinance amending the Code of Ordinances of the City of Washington, Illinois by amending 75.10A entitled "90 Day Load Limit on Certain City Streets" and 75.10B entitled "Commercial Vehicles Prohibited on Certain City Streets." Adoption of this ordinance would better define and codify truck operating weights on local streets within the City of Washington; and an ordinance amending the Code of Ordinances of the City of Washington, Illinois by amending 50.50 entitled "Rates for City Water Service" and 52.103 entitled "Base User Charge; Calculation of Rate." Adoption of this ordinance would update portions of the water and sewer rates as currently defined under Chapter 50 and Chapter 52 of the City Code, respectively. These ordinances will be listed on the next meeting agenda for action.

Public Works Director Andrews requested Council authorization to amend the inspection services contract with Strand Engineering as part of the Sewer Treatment Plant No. 2, Phase 2A final closeout by increasing Strand's inspection services by an amount of \$15,000. He shared this request is appropriate when reviewed against the IEPA percentage of the final construction and would be the final adjustment for the completion of the final project. Alderman Brownfield moved and Alderman Butler seconded to authorize the request as presented. There was no further discussion and on roll call the vote was:

Mayor Manier expressed his appreciation on the decision that was made early yesterday to get the trucks out. P & D Director reminded everyone of the Take Pride in Washington event scheduled for April 27th rain or shine and encouraged everyone to sign up. He also shared that Ameren's Brighten the Block campaign is scheduled for April 24th and will begin at 3:00 p.m. on the SE side of the city where 150-200 homes are identified to receive more energy efficient porch lighting.
